



## RWANDA STOCK EXCHANGE MARKET REPORT FOR FRIDAY 03<sup>RD</sup> DECEMBER 2021

### 1. Market overview

- The trading session recorded a total turnover of Frw 6,441,800 worth of bonds traded in 1 deal on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- Equities counters closed as follows: BLR: Frw 120; BOK: Frw 250; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 23,000 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 520,600 shares between Frw 180-195 and no bids. On BLR counter, there were outstanding offers of 82,300 shares at Frw 120 and outstanding bids of 110,000 shares between Frw 115-116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 374,600 shares between Frw 45-47 and no bids.

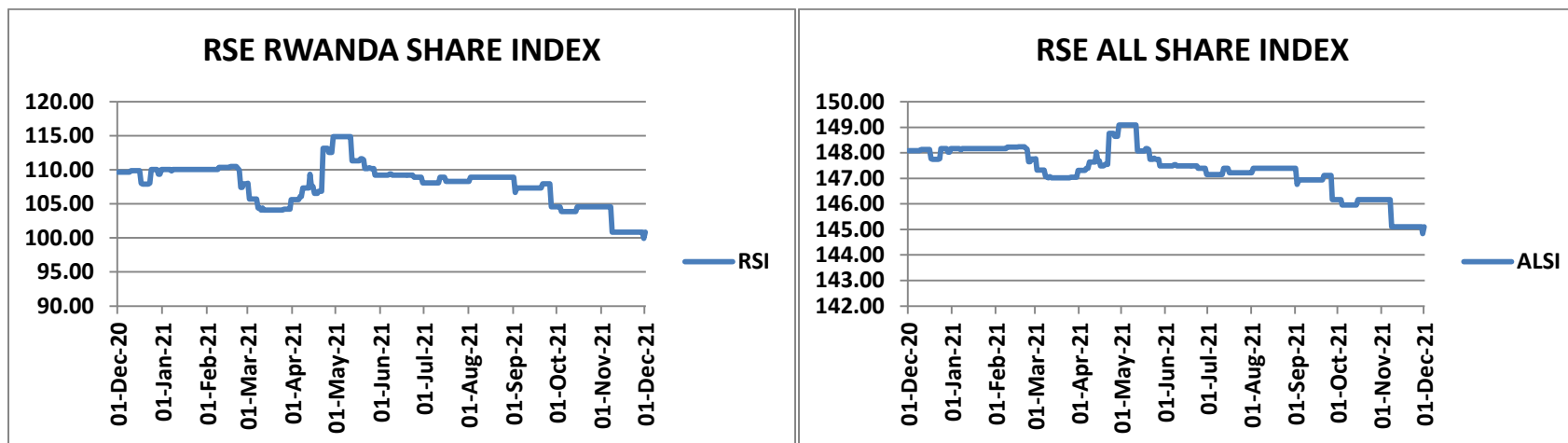

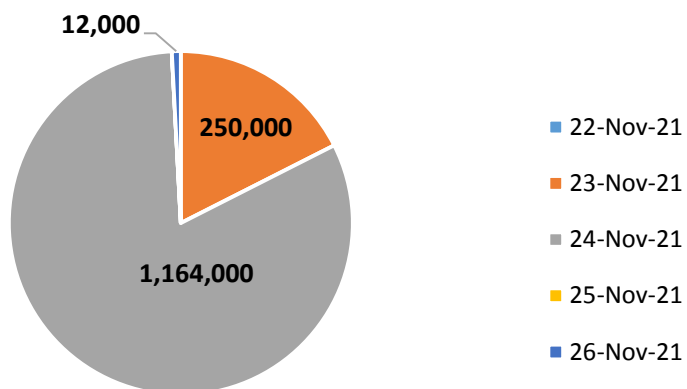

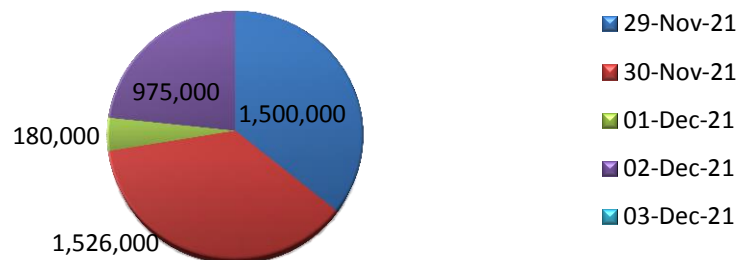
