



RWANDA STOCK EXCHANGE MARKET REPORT FOR FRIDAY 09TH SEPTEMBER 2022

1. Market overview

- The trading session recorded a total turnover of Frw 79,581,050 worth of bonds traded in 6 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 108.91 and 147.39 respectively.
- Equities counters closed as follows: BLR: Frw 165; BOK: Frw 272; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 737,300 shares between Frw 275 - 290 and an outstanding bid of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,130,100 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 109,900 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 62,200 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 101,800 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

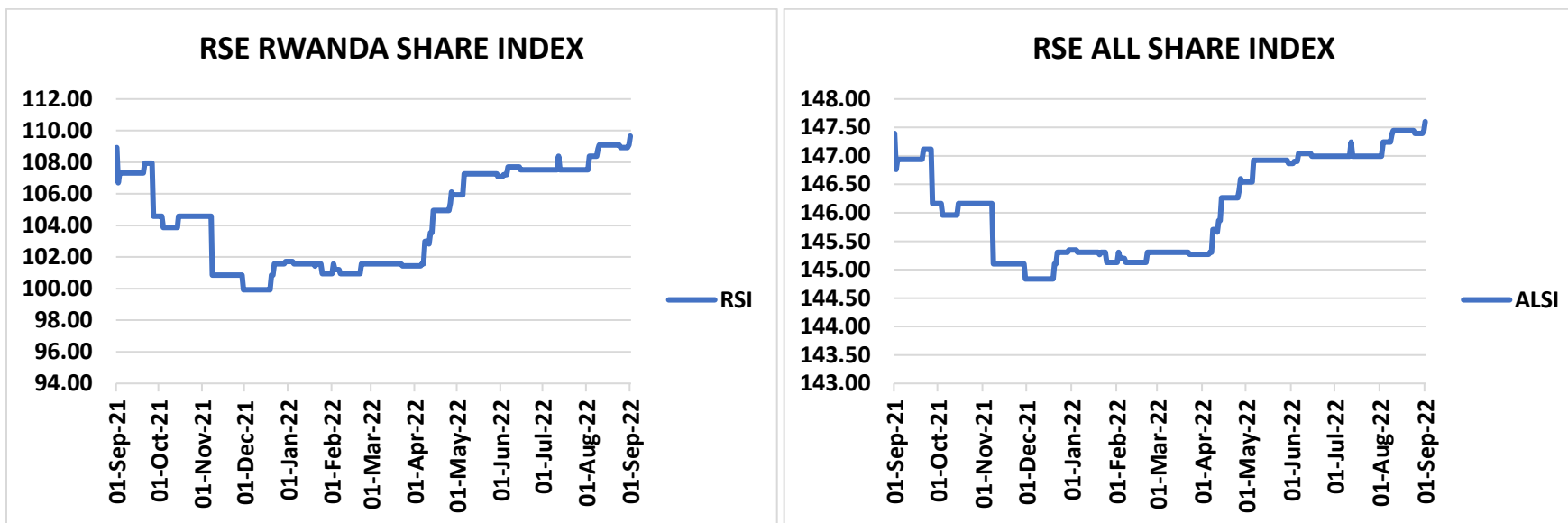

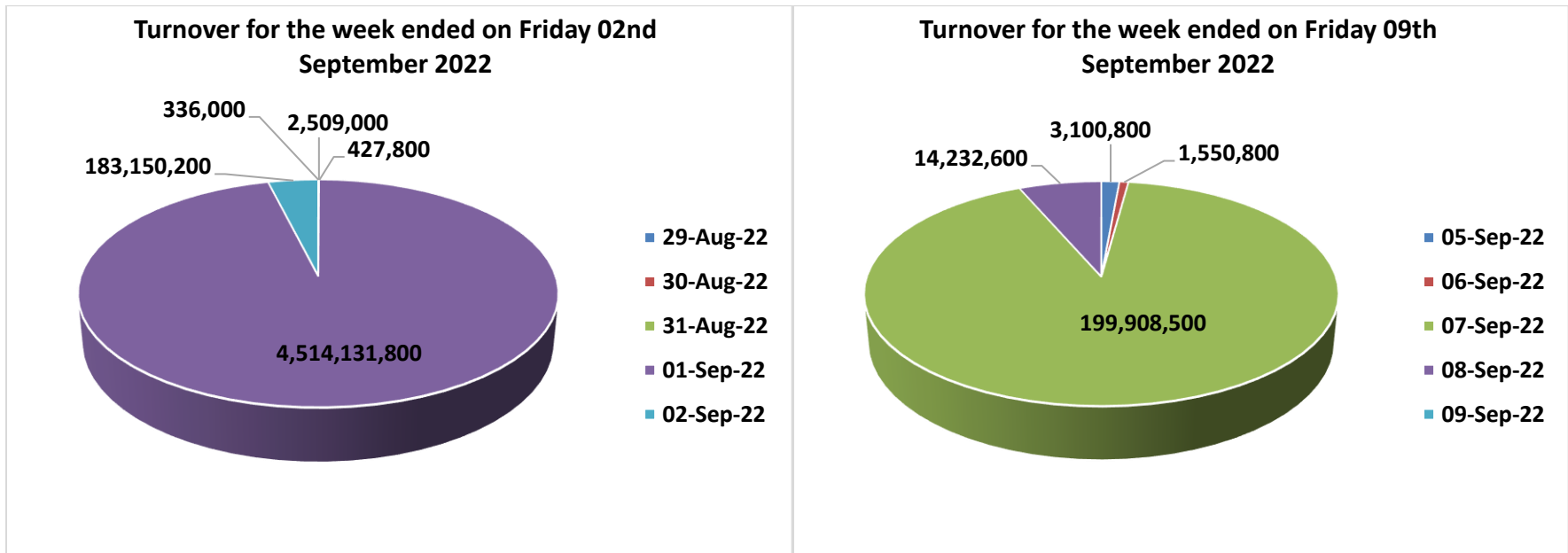
