



RWANDA STOCK EXCHANGE MARKET REPORT FOR FRIDAY 10TH SEPTEMBER 2021

1. Market overview

- Today's trading session recorded a turnover of Frw 229,500 from 4,100 shares traded in 3 deals on the equities market and Frw 207,000 worth of bonds traded in 1 deal on the fixed income market.
- RSI and ALSI remained constant to close at 107.31 and 146.93 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 157,500 from 3,500 shares traded in 2 deals.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 72,000 from 600 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 245; CMR: Frw 120; MTNR: Frw 218; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; on BOK counter, there was an outstanding offer of 13,100 shares at Frw 240 and no bids. On MTNR counter, there were outstanding offers 440,000 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 60,100 shares between Frw 120-125 and no bids. On CMR counter, there was an outstanding offer of 120,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 285,900 shares between Frw 45-47 and no bids.

On bonds market; there were outstanding bonds of Frw 8,600,000 worth of bonds between Frw 101.2-104.1 and no bids.

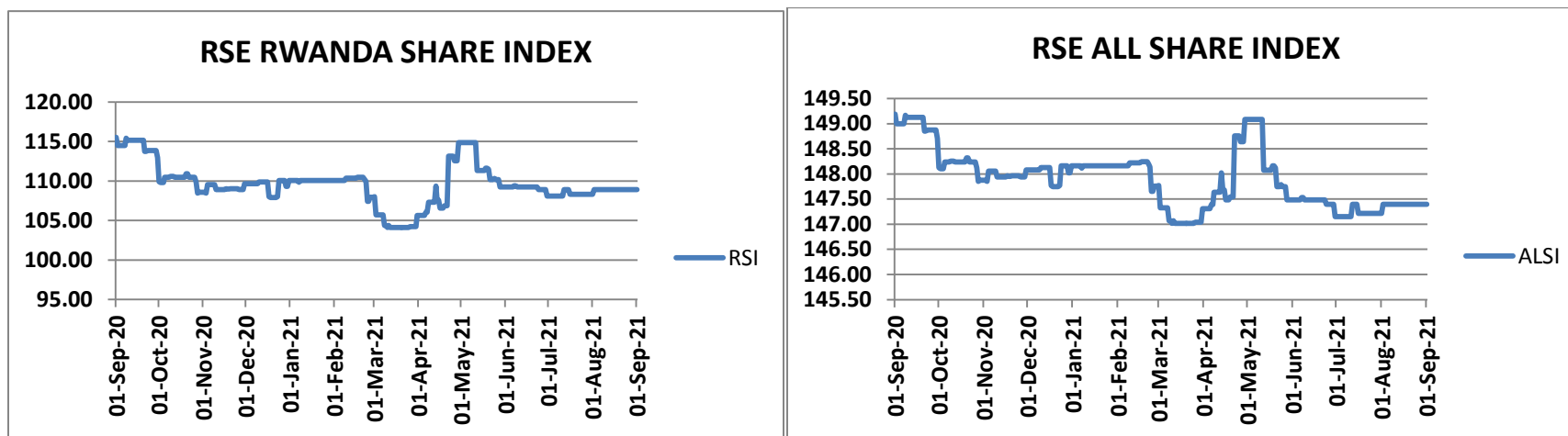

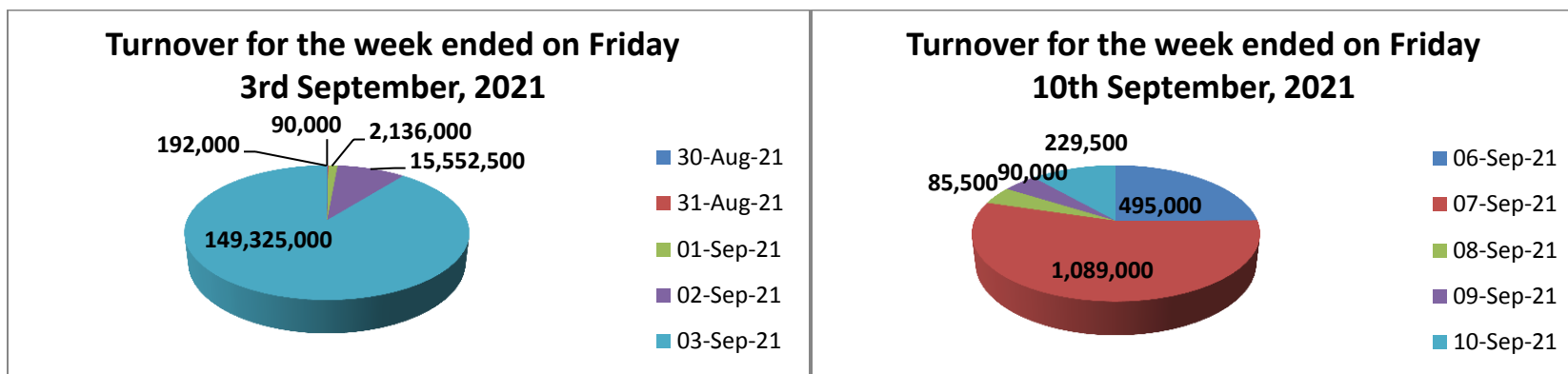
