



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 03RD OCTOBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 29,298,800 from 132,200 shares traded in 4 deals on the equities market and Frw 1,250,000 worth of bonds traded in 2 deals on the fixed income market.
- RSI and ALSI went up by 0.63 and 0.17 points to close at 109.36 and 147.52 respectively.
- MTNR counter closed at Frw 176 (Frw 176 previous). The trading session recorded a total turnover of Frw 9,020,800 from 55,800 shares traded in 2 deals.
- BOK counter closed at Frw 270 (Frw 265 previous). The trading session recorded a total turnover of Frw 19,683,000 from 72,900 shares traded in 1 deal.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 595,000 from 3,500 shares traded in 1 deal.
- Equities counters closed as follows: IMR: Frw 43; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 356,900 shares at Frw 290 and an outstanding bid of 51,000 shares between Frw 265 - 270. On MTNR counter, there were outstanding offers of 1,514,100 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 12,800 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 146,600 shares between Frw 42 - 45 and no bids. On CMR counter, there were outstanding offers of 105,800 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

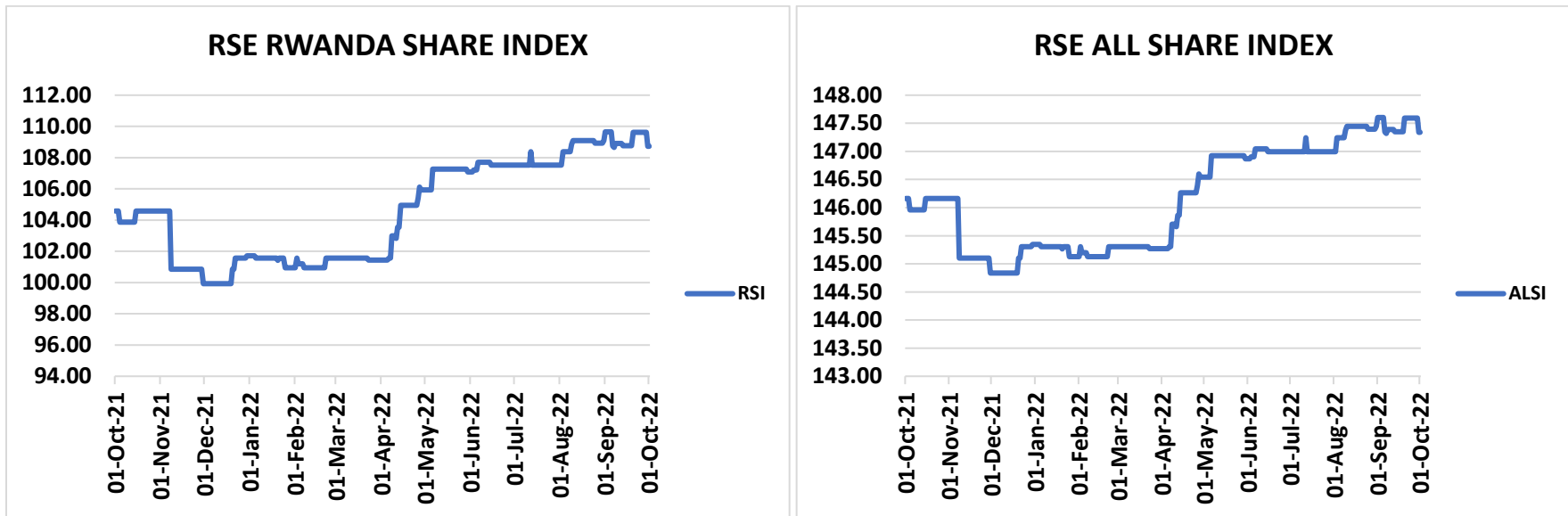
