



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 05TH OCTOBER, 2020

1. Market overview

- Today's trading session recorded on the equities market a total of Frw 419,400 with IMR increasing 3 points to close at Frw 45 while the fixed income market was quiet.
- RSI and ALSI went up 0.68 and 0.12 points to close at 110.62 and 148.28 respectively.
- BOK counter closed at Frw 233 (Frw 233 previous). The trading session recorded a total turnover of Frw 302,900 from 1,300 shares traded in 1 deal.
- CTL counter closed at Frw 70 (Frw 70 previous). The trading session recorded a total turnover of Frw 112,000 from 1,600 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 42 previous). The trading session recorded a total turnover of Frw 4,500 from 100 shares traded in 1 deal.

- Equities counters closed as follows: CMR: Frw 120; BLR: Frw 124; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 278,300 shares between Frw 233-260 and no bids. On BLR counter, there were outstanding offers of 955,500 shares between Frw 125-145 and no bids. On CTL counter, there were outstanding offers of 50,800 shares between Frw 72-75 and an outstanding bid of 5,000 shares at Frw 70. On IMR counter, there were outstanding offers of 221,900 shares between Frw 45-46 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids.

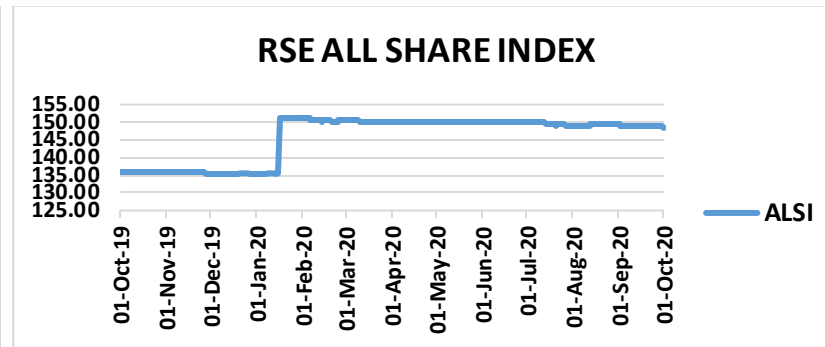
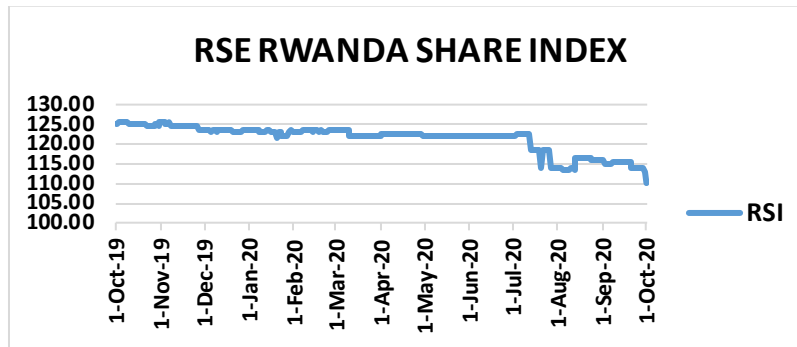
