



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 05TH SEPTEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 391,817,000 worth of bonds traded in 3 deals on the fixed income market and Frw 3,100,800 from 11,400 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 109.65 and 147.60 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 3,100,800 from 11,400 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 165; IMR: Frw 43; MTNR: Frw 180; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 356,900 shares at Frw 290 and an outstanding bid of 22,000 shares between Frw 245 - 247. On MTNR counter, there were outstanding offers of 1,106,400 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 65,800 shares between Frw 160 - 165 and no bids. On IMR counter, there were outstanding offers of 77,400 shares between Frw 42 - 43 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

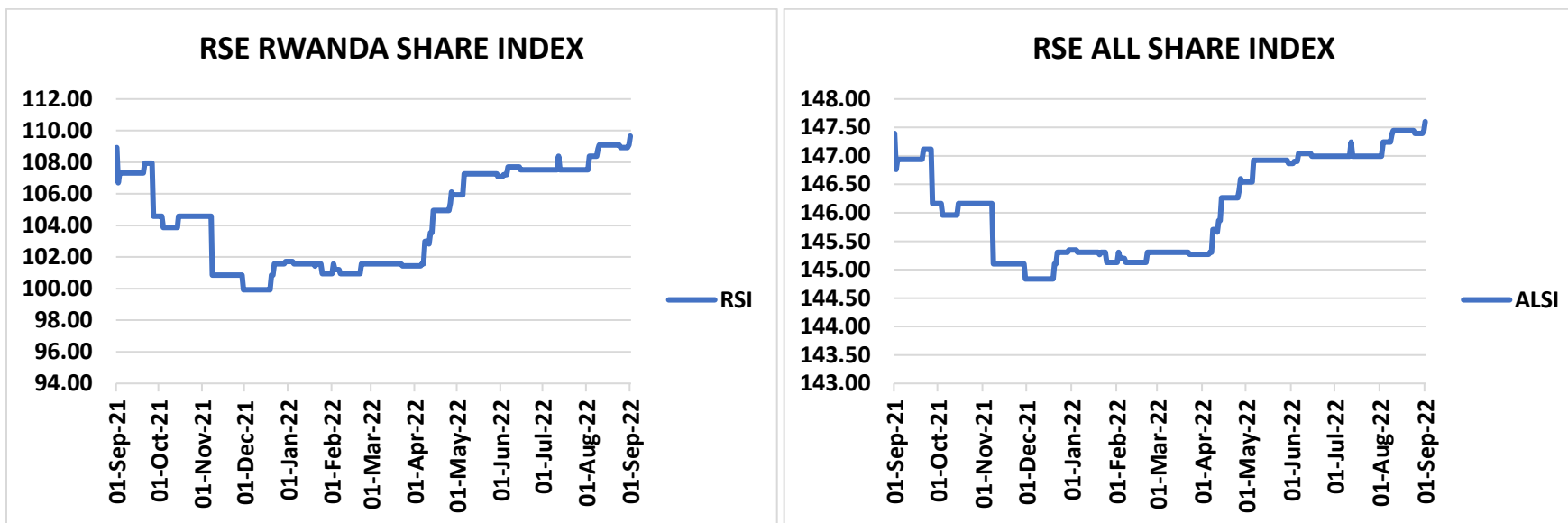
