



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 6TH SEPTEMBER 2021

1. Market overview

- Today's trading session recorded a turnover of Frw 695,680,000 worth of bonds traded in 11 deals on the fixed income market and Frw 495,000 from 11,000 shares traded in 3 deals on the equities market.
- RSI and ALSI remained constant to close at 107.31 and 146.93 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 495,000 from 11,000 shares traded in 3 deals.
- Equities counters closed as follows: BLR: Frw 120; BOK: Frw 245; CMR: Frw 120; MTNR: Frw 218; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; on BOK counter, there were no offers and no bids. On MTNR counter, there were outstanding offers 852,800 shares between Frw 220-245 and no bids. On BLR counter, there were outstanding offers of 60,100 shares between Frw 120-125 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 287,700 shares between Frw 45-47 and no bids.

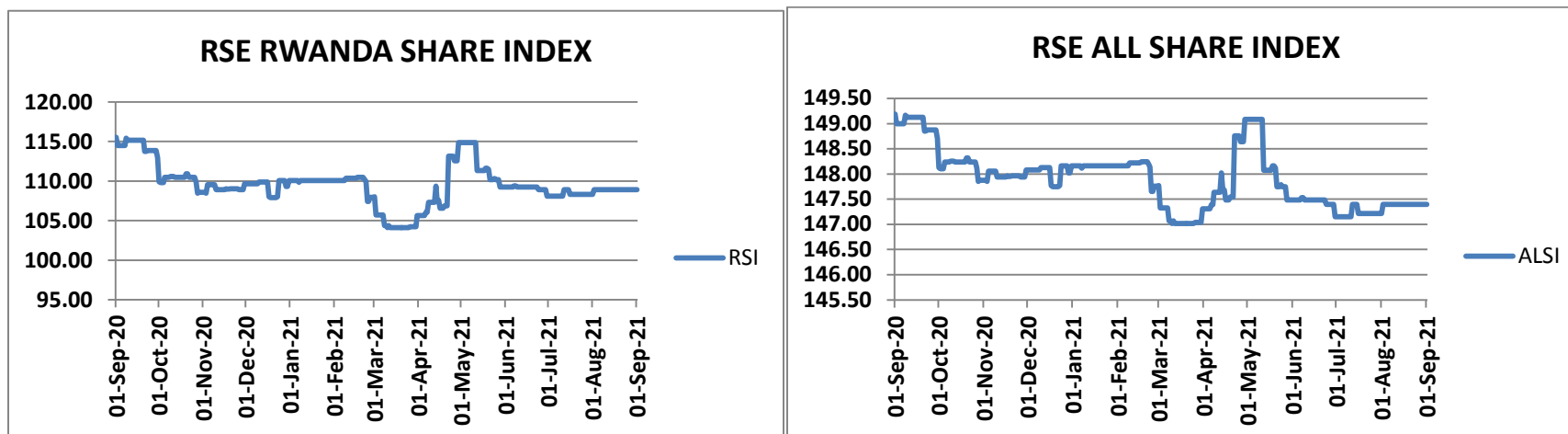
