



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 07TH FEBRUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 220,766,000 worth of bonds traded in 4 deals on the fixed income market and Frw 7,350,000 from 30,000 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI went down by 0.24 and 0.07 points to close at 100.94 and 145.12 respectively.
- BOK counter closed at Frw 245 (Frw 247 previous). The trading session recorded a total turnover of Frw 7,350,000 from 30,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 125; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 82,000 shares at Frw 250 and outstanding bids of 27,000 shares between Frw 240-245. On MTNR counter, there were outstanding offers of 650,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 100,700 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 472,200 shares at Frw 45 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market; there was an outstanding offer of Frw 10,000,000 worth of bonds at Frw 106 and no bids.

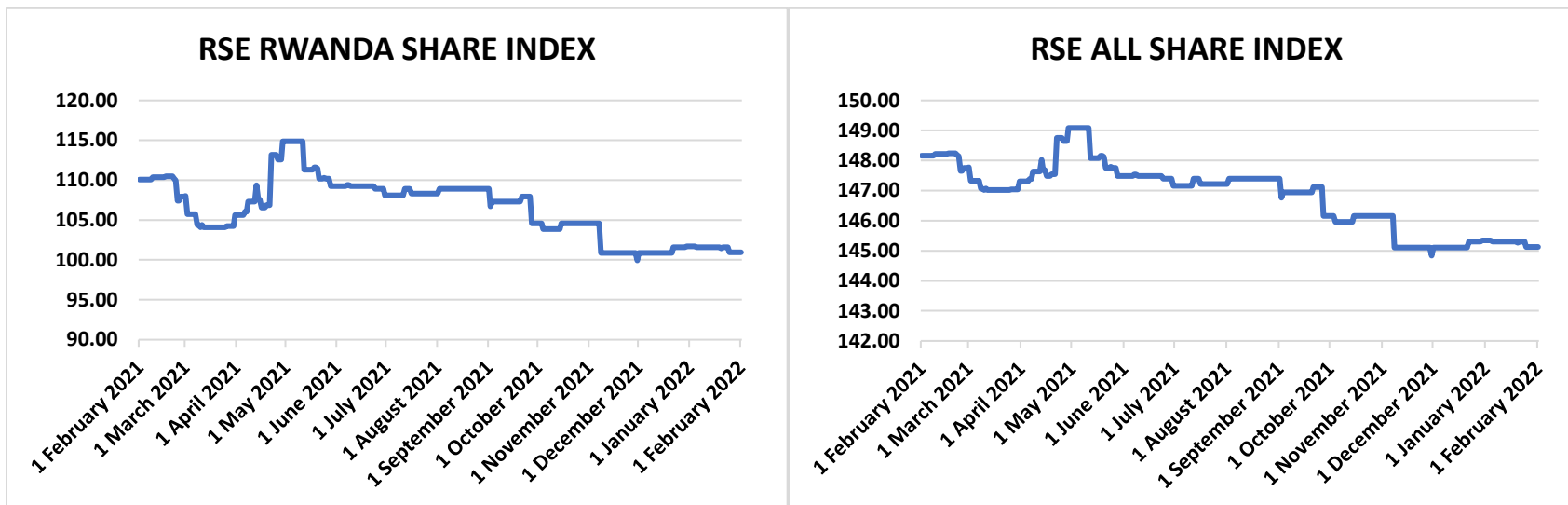
