



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 07<sup>TH</sup> MARCH 2022

### 1. Market overview

- Today's trading session recorded Frw 38,585,000 worth of bonds traded in 4 deals on the fixed income market and Frw 211,500 from 3,200 shares traded in 2 deals on the equities market.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 90,000 from 500 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 121,500 from 2,700 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 250; BLR: Frw 125; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 59,400 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 650,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 97,400 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 450,000 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market; there were outstanding offers of Frw 100,000,000 worth of bonds between Frw 102 - 104.6 and no bids.

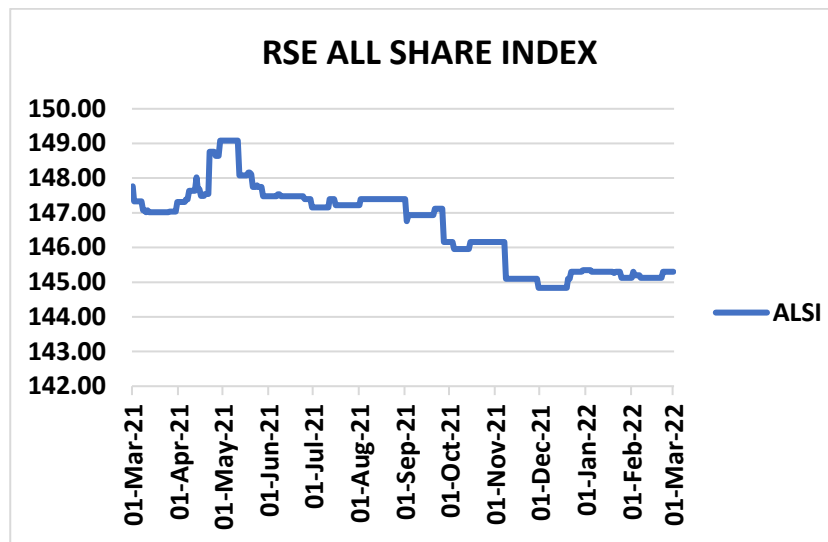
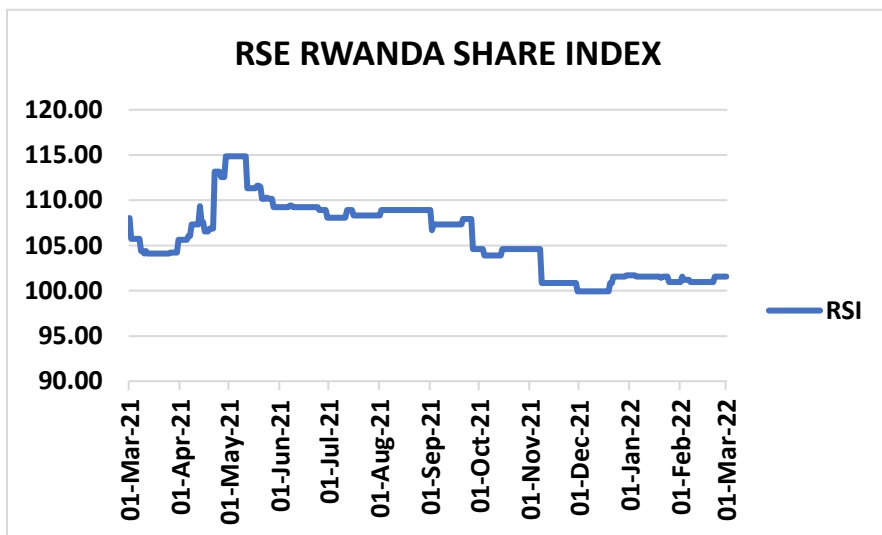
