



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 08<sup>TH</sup> AUGUST 2022

### 1. Market overview

- The trading session recorded a total turnover of Frw 7,646,400 worth of bonds traded in 1 deal on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 108.39 and 147.24 respectively.
- Equities counters closed as follows: BLR: Frw 160; BOK: Frw 272; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 356,500 shares at Frw 290 and no bids. On MTNR counter, there were outstanding offers of 1,030,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 115,000 shares between Frw 165 - 176 and no bids. On IMR counter, there were outstanding offers of 96,200 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 112,000 shares at Frw 120 and no bids.

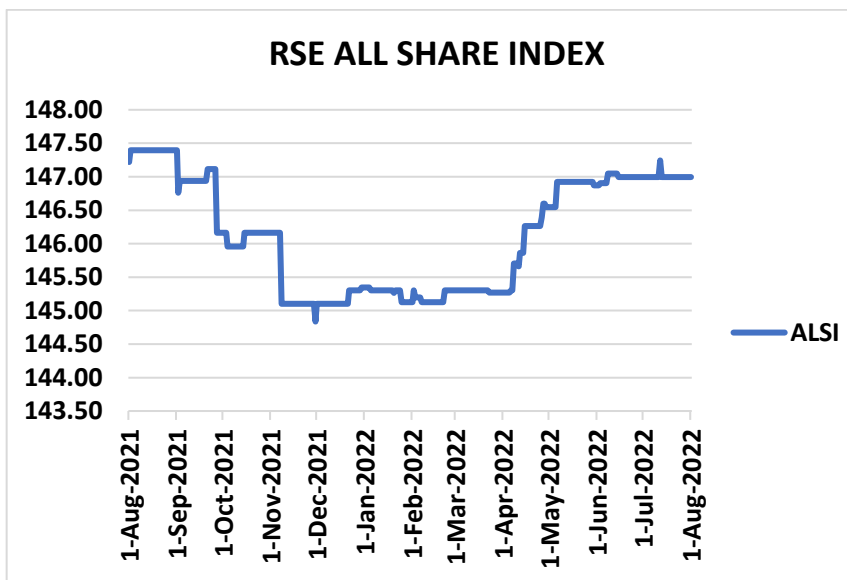
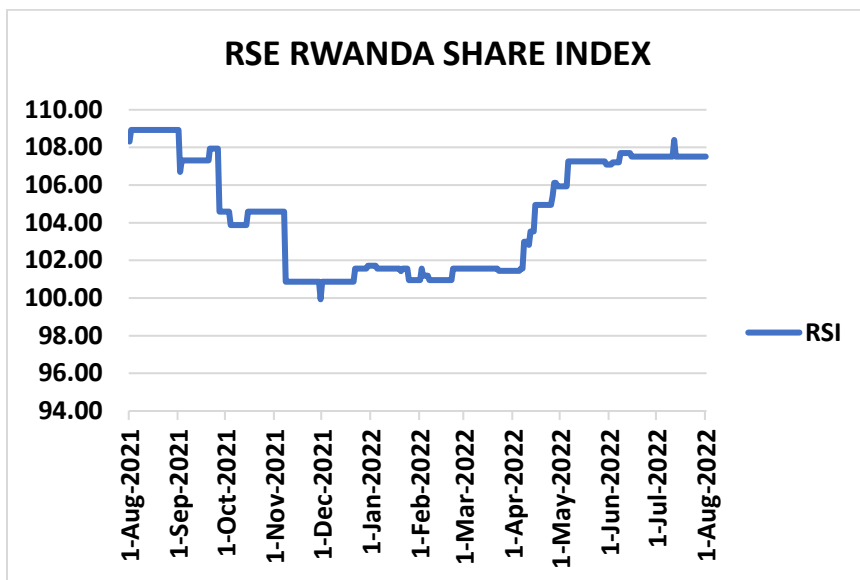
