- RSI and ALSI remained constant to close at 123.40 and 150.41 respectively.

- BLR counter closed at Frw 139 (Frw 139 previous). The trading session recorded a total turnover of Frw 13,900 from 100 shares traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 70; IMR: Frw 89; BOK: Frw 265; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

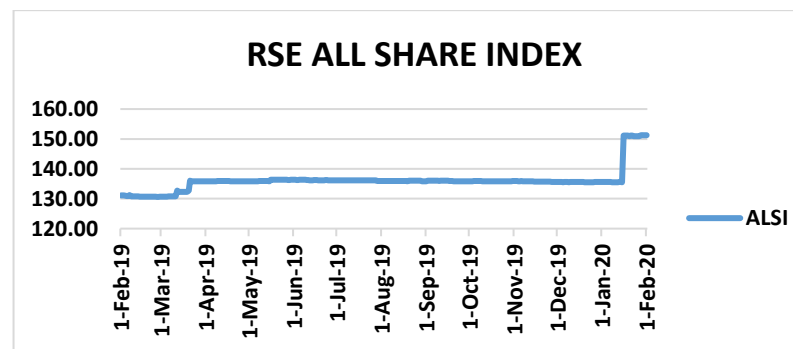
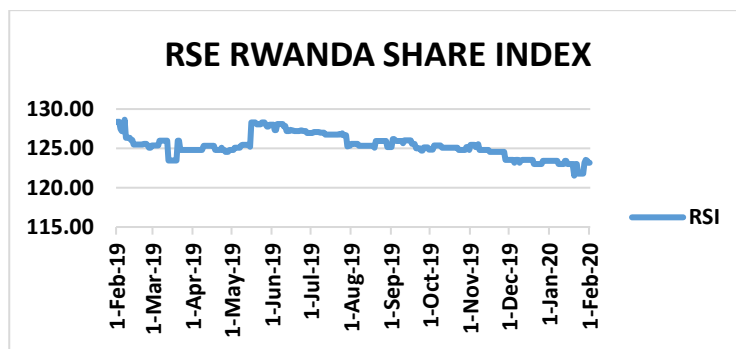
