



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 10TH JULY 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 62,379,800 worth of bonds traded in 3 deals on the fixed-income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 112.83 and 143.65 respectively.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 286; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 172; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 578,100 shares between Frw 172-180 and no bids. On IMR counter, there were outstanding offers of 228,200 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 170,600 shares between Frw 175-179 and an outstanding bid of 268,100 shares at Frw 165-172. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 132 and no bids.

On the bonds market, there were outstanding offers of Frw 63,800,000 worth of bonds between Frw 100.2-103 and no bids.

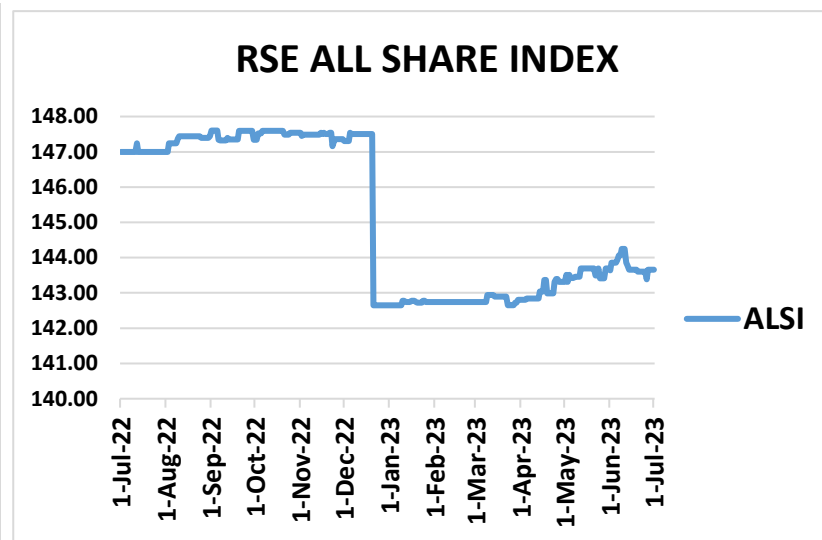
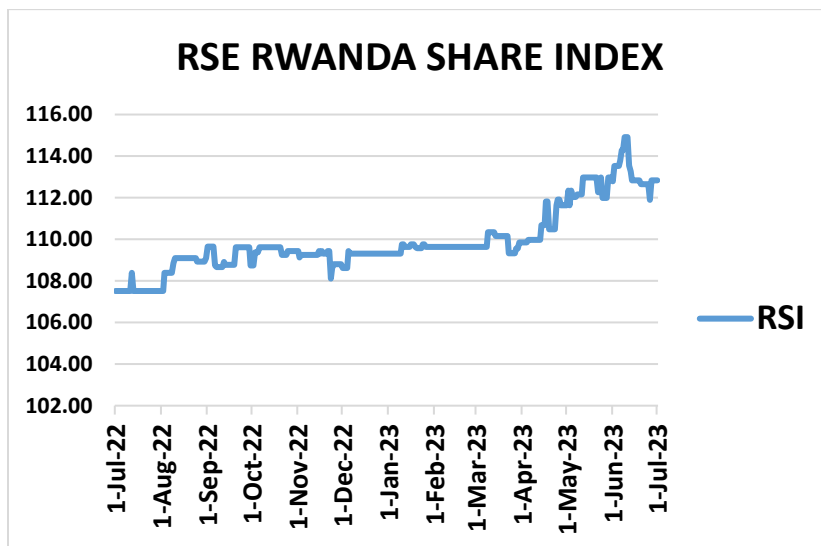
