



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 12<sup>TH</sup> SEPTEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 133,984,200 from 526,400 shares traded in 7 deals on the equities market and Frw 116,057,640 worth of bonds traded in 4 deals on the fixed income.
- RSI and ALSI remained constant to close at 108.91 and 147.39 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 121,636,000 from 450,500 shares traded in 2 deals.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 12,276,000 from 74,400 shares traded in 3 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 60,200 from 1,400 shares traded in 1 deal.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 12,000 from 100 shares traded in 1 deal.

- Equities counters closed as follows: MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 737,300 shares between Frw 275 - 290 and outstanding bids of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,133,400 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 515,200 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 77,200 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 101,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

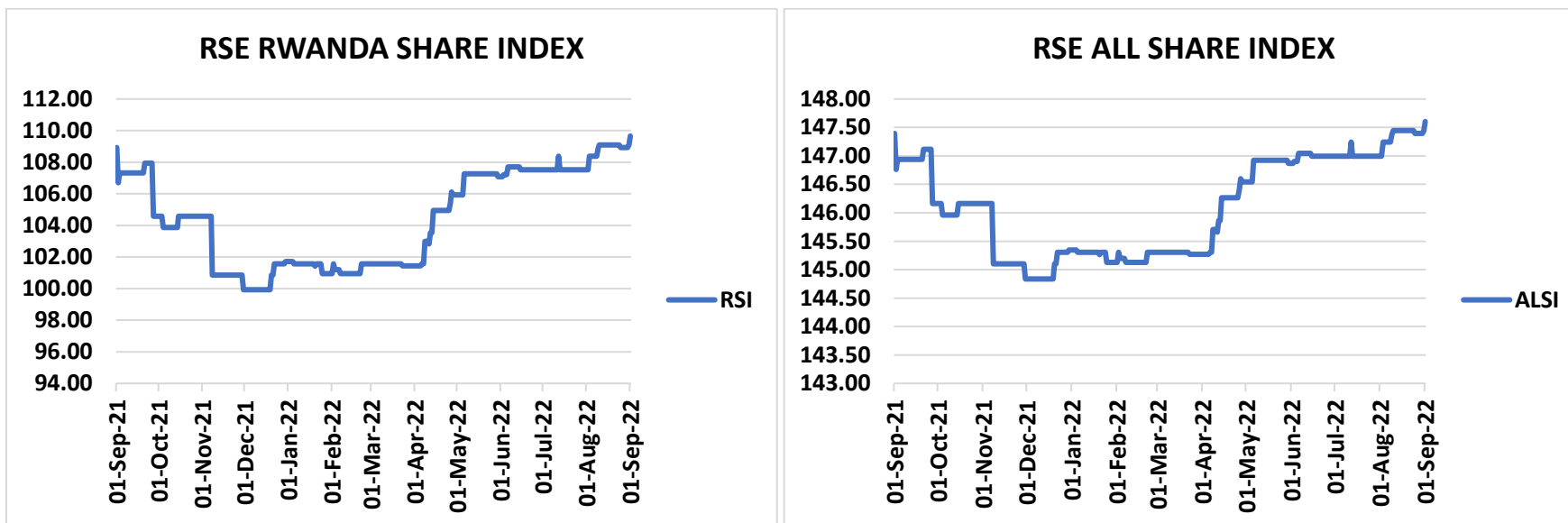
