- Both RSI and ALSI remain constant to close at 123.54 and 135.61 respectively.
- Today's trading session recorded a total of Frw 714,000,000 worth of bond traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 70; BOK: Frw 265; BLR: Frw 139; IMR: Frw 90; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

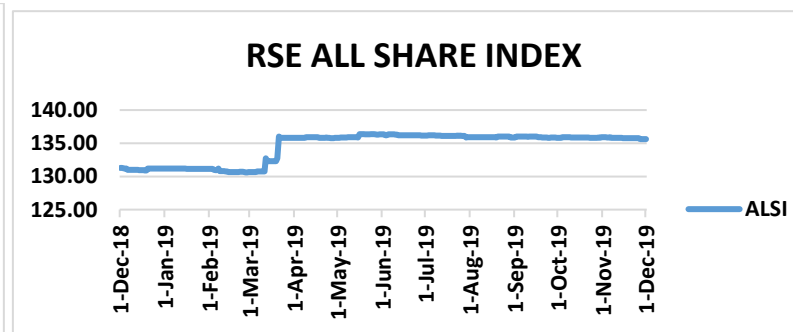
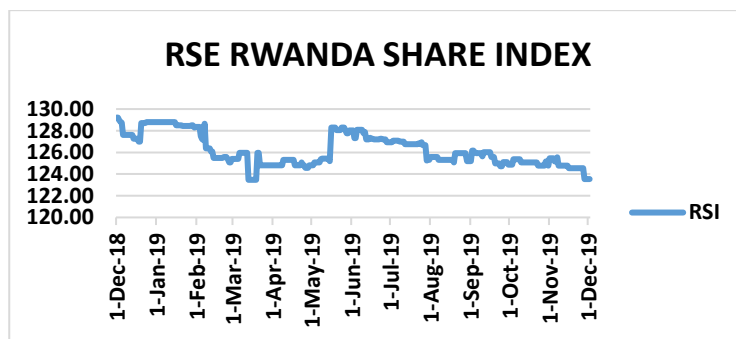
