



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 16TH OCTOBER 2023

1. Market overview

- Today's trading session recorded a total turnover of Frw 71,394,700 from 328,400 shares while the fixed-income market was quiet.
- RSI and ALSI went up to close at 113.22 and 143.76 respectively.
- BOK counter closed at Frw 292 (Frw 290 previous). The trading session recorded a total turnover of Frw 34,767,200 from 119,100 shares traded in 2 deals.
- BLR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 36,627,500 from 209,300 shares traded in 3 deals.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 292; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 170; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 459,800 shares between Frw 170-176 and no bids. On IMR counter, there were outstanding offers of 264,100 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 194,700 shares between Rwf 175-180 and no bids. On EQTY counter, there was an outstanding bid of 200 shares at Frw 440 and no offer.

On the bonds market, there were outstanding offer of Frw 50,500,000 at Frw 102.03 and no bids.

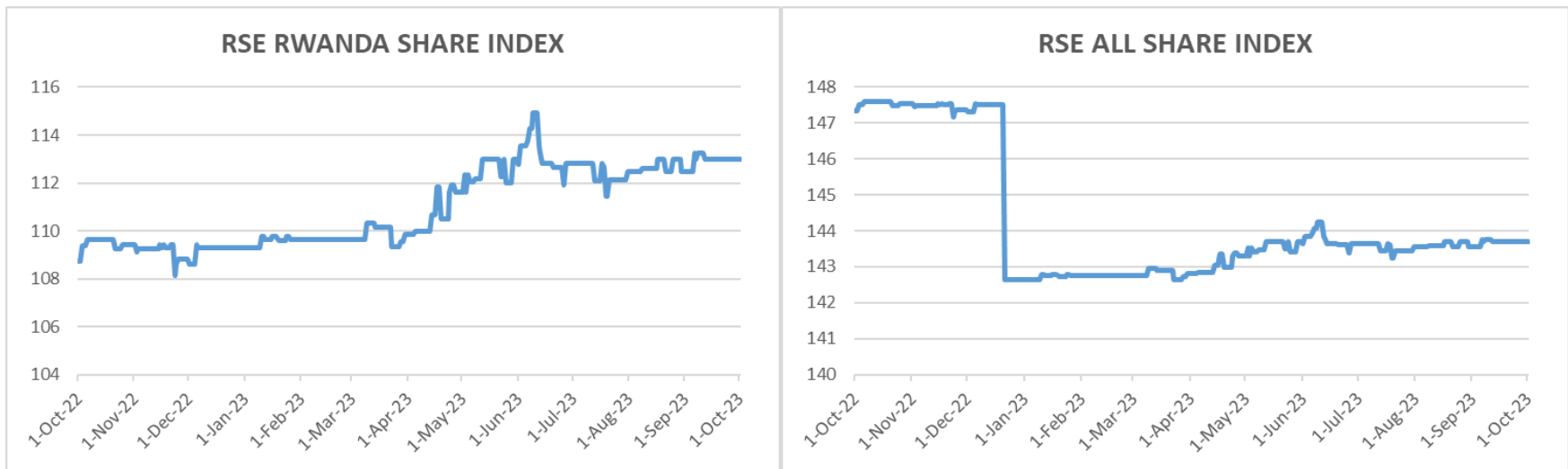
