



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 17TH JANUARY 2022

1. Market overview

- The trading session remained quiet as no transactions were recorded both on the equities and the fixed income markets.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- Equities counters closed as follows: BLR: Frw 125; BOK: Frw 250; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 30,300 shares at Frw 250 and an outstanding bid of 5,000 shares at Frw 245. On MTNR counter, there were outstanding offers of 700,000 shares between Frw 180-190 and no bids. On BLR counter, there were outstanding offers of 92,600 shares at Frw 125 and outstanding bids of 110,000 shares between Frw 116-120. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 473,900 shares at Frw 45 and no bids.

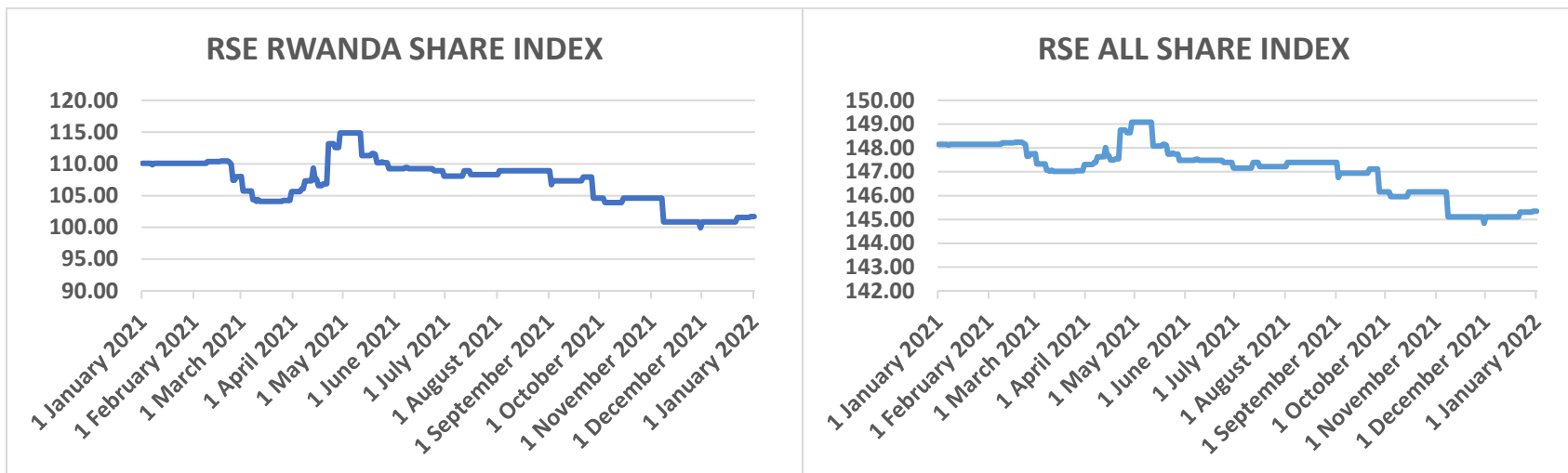
