



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 17TH JULY 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 35,429,400 worth of bonds traded in 4 deals on the fixed-income market and Frw 286,000 from 1,000 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI went up 0.75 and 0.21 points to close at 112.83 and 143.66 respectively.
- BOK counter closed at Frw 286 (Frw 280 previous). The trading session recorded a total turnover of Frw 286,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 286; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 172; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 578,100 shares between Frw 172-180 and no bids. On IMR counter, there were outstanding offers of 228,200 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 76,100 shares between Frw 170-175 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 132 and no bids.

On the bonds market, there was an outstanding offer of Frw 30,000,000 no bids.

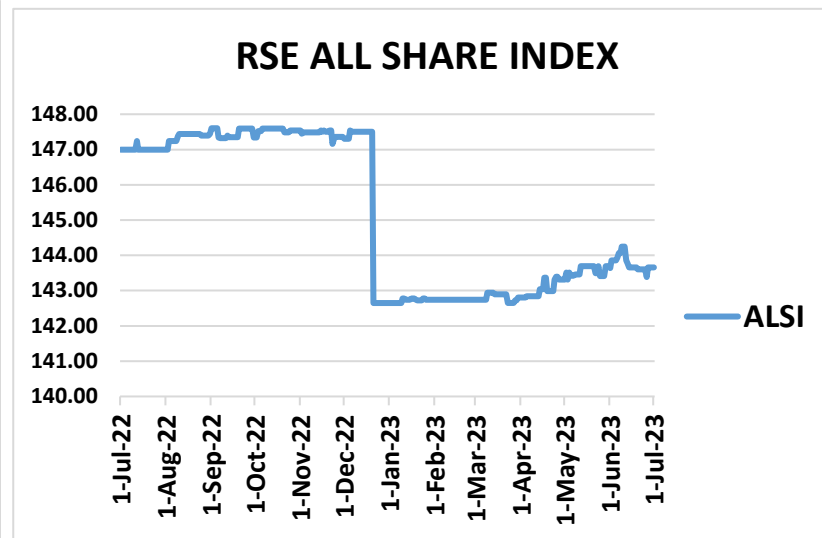
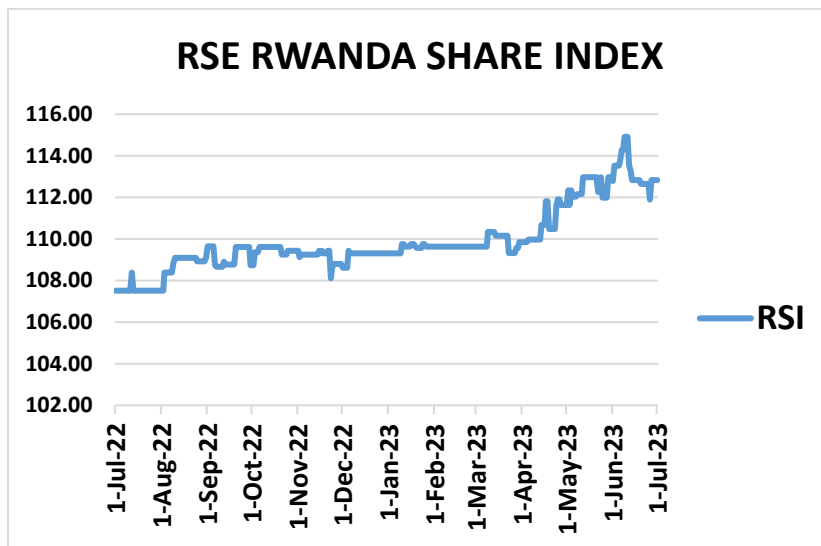
