



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 17TH OCTOBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 7,687,500 worth of bonds traded in 1 deal on the fixed income market and Frw 25,800 from 600 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 25,800 from 600 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 272; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 78,000 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,317,900 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 9,600 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 227,000 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 104,700 shares at Frw 120 and no bids.

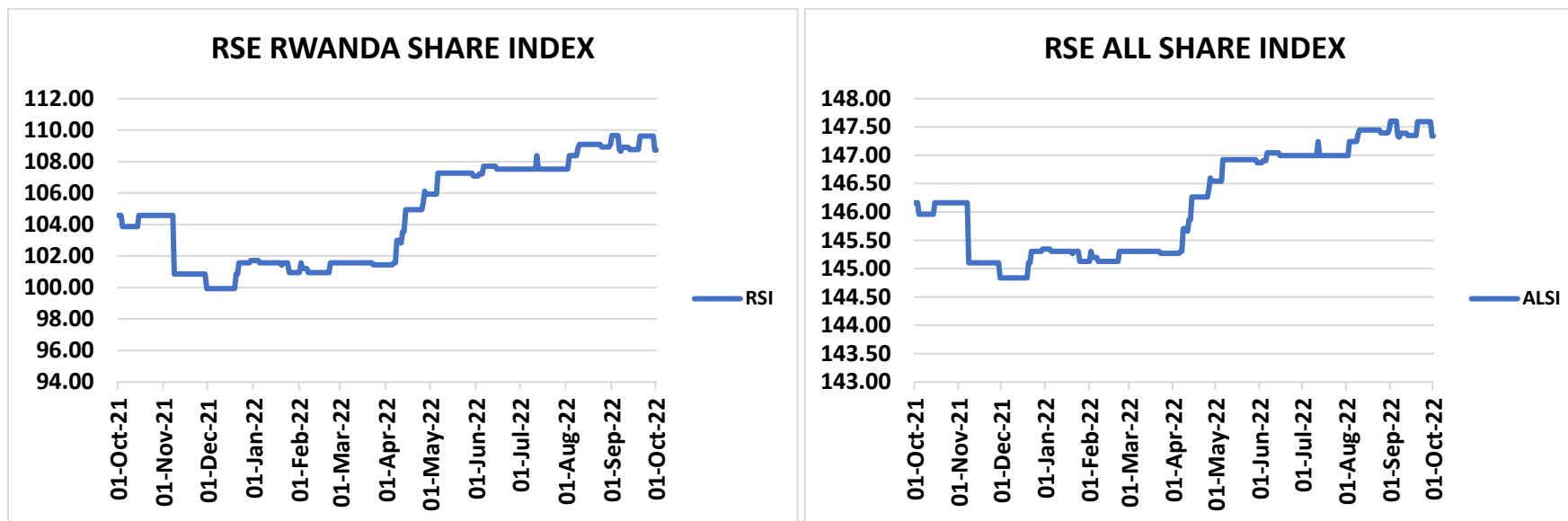
