



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 19TH SEPTEMBER 2022

1. Market overview

- The trading session recorded a total turnover of Frw 77,400 from 1,800 IMR shares traded in 1 deal on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 108.77 and 147.35 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 77,400 from 1,800 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 164; BOK: Frw 272; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 376,900 shares between Frw 272 - 290 and an outstanding bid of 1,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,305,700 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 1,400 shares at Frw 170 and an outstanding bid of 3,000 shares at Frw 160. On IMR counter, there were outstanding offers of 170,000 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 101,700 shares at Frw 120 and no bids.

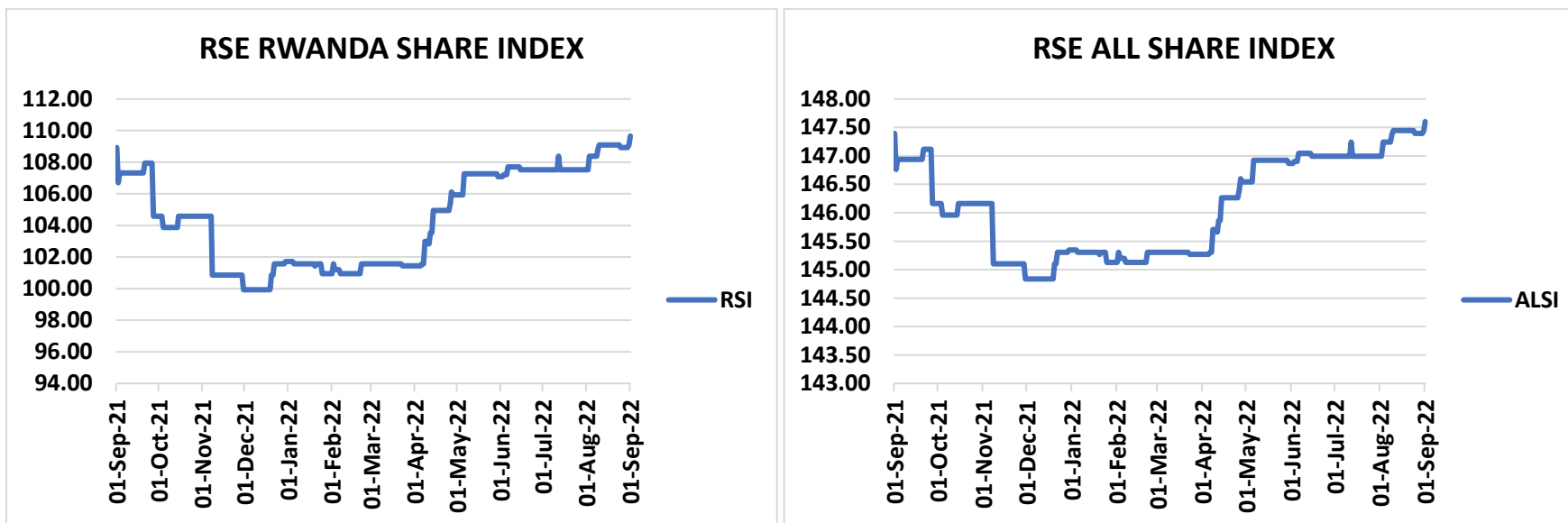
