



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 20<sup>TH</sup> DECEMBER 2021

### 1. Market overview

- The trading session recorded a total turnover of Frw 254,000 from 1,900 shares traded in 3 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 50,000 from 200 shares traded in 1 deal.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 204,000 from 1,700 shares traded in 2 deals.
- Equities counters closed as follows: IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 30,400 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 512,000 shares between Frw 180-195 and no bids. On BLR counter, there were outstanding offers of 10,300 shares at Frw 125 and outstanding bids of 100,000 shares at Frw 116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 603,200 shares at Frw 45 and no bids.

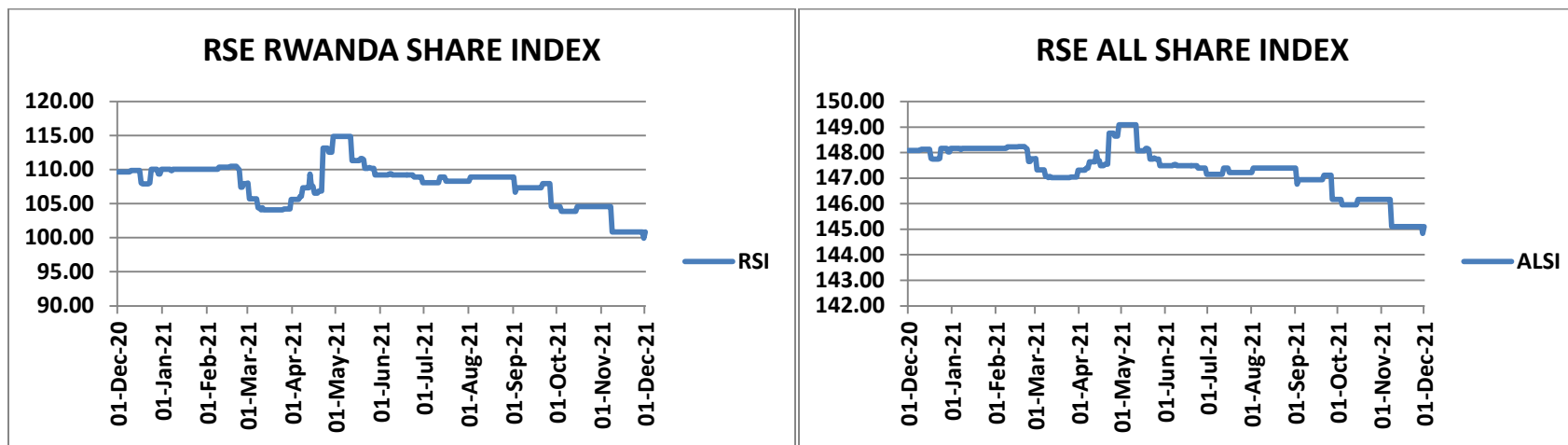
