



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 20TH FEBRUARY 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 176,054,500 worth of bonds traded in 8 deals on the fixed-income market and Frw 514,000 from 3,000 shares traded in 3 deals on the equities market.
- RSI and ALSI remained constant to close at 109.63 and 142.74 respectively.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 374,000 from 2,200 shares traded in 2 deals.
- MTNR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 140,000 from 800 shares traded in 1 deal.
- Equities counters closed as follows: MTNR: Frw 175; BOK: Frw 271, IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 46,700 shares between Frw 271-272 and no bids. On MTNR counter, there were outstanding offers of 1,237,100 shares between Frw 175-180 and no bids. On BLR counter, there was an outstanding offer 1,800 shares at Frw 170 and an outstanding bid of 80,000 shares at Frw 160. On IMR counter, there were outstanding offers of 239,300 shares at Frw 45 and an outstanding bid of 2,000 shares at Frw 40. On CMR counter, there were outstanding bids of 6,000 shares between Frw 122-135 and no offers.

On the bonds market, there were no offers and no bids.

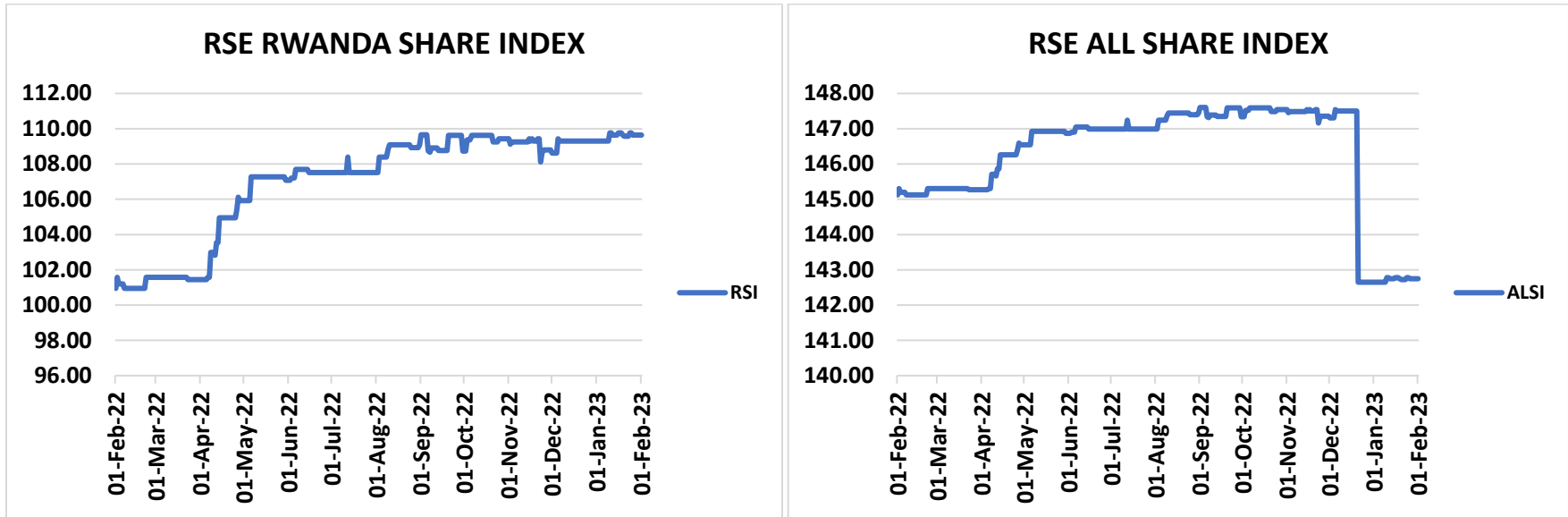
