



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 20TH MARCH 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 240,058,400 worth of bonds traded in 5 deals on the fixed-income market and Frw 265,000 from 3,000 shares traded in 2 deals on the equities market.
- RSI and ALSI remained constant to close at 110.15 and 142.89 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 90,000 from 2,000 shares traded in 1 deal.
- BLR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 175,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 271; CMR: Frw 120; MTNR: Frw 174; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 43,100 shares between Frw 271 - 280 and an outstanding bid of 25,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,290,100 shares between Frw 174 - 180 and no bids. On BLR counter, there were outstanding bids of 20,400 shares between Frw 160 - 170 and an outstanding offer of 49,000 shares at Frw 175. On IMR counter, there were outstanding offers of 245,400 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 25,100 shares between Frw 122 - 125 and no offers.

On the bonds market, there were no offers and no bids.

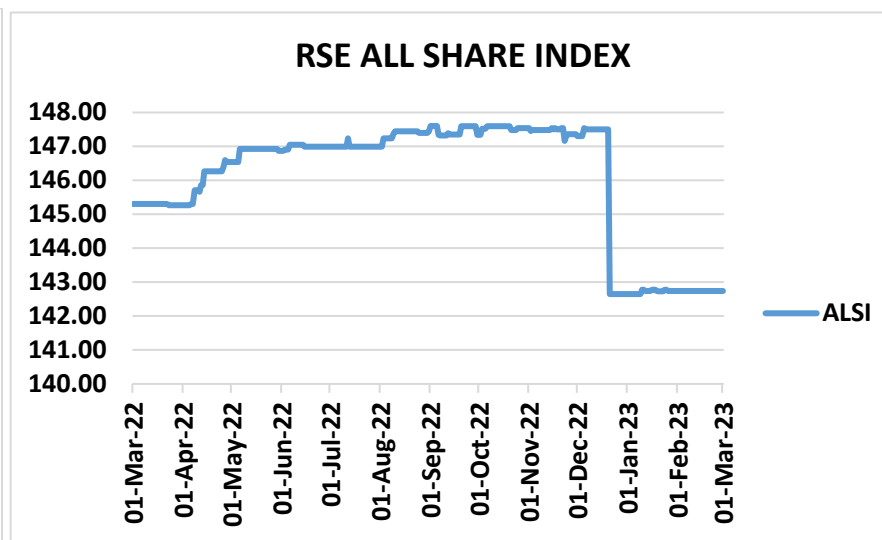
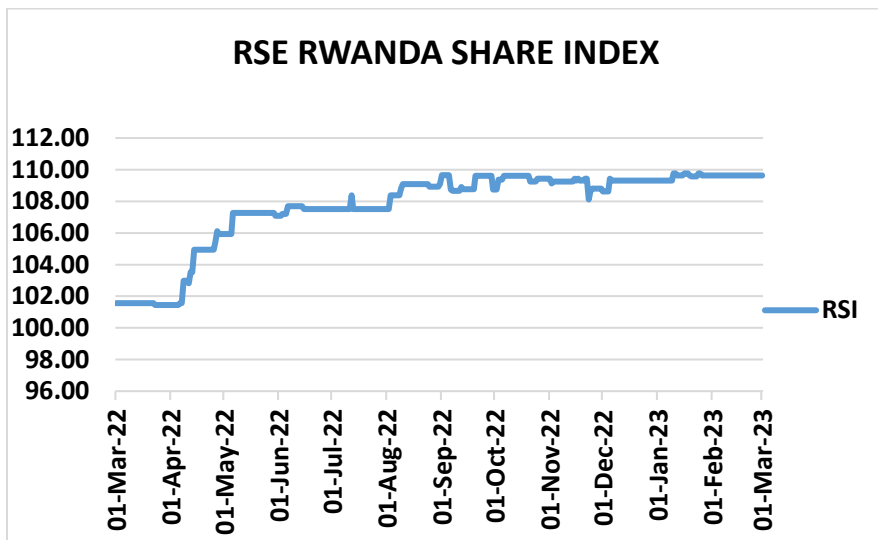
