



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 21ST FEBRUARY 2022

1. Market overview

- Today's trading session recorded a total turnover of Frw 770,145,000 worth of bonds traded in 2 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 100.94 and 145.12 respectively.
- Equities counters closed as follows: BLR: Frw 125; BOK: Frw 245; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 19,800 shares between Frw 249-250 and no bids. On MTNR counter, there were outstanding offers of 750,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 109,000 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 372,200 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

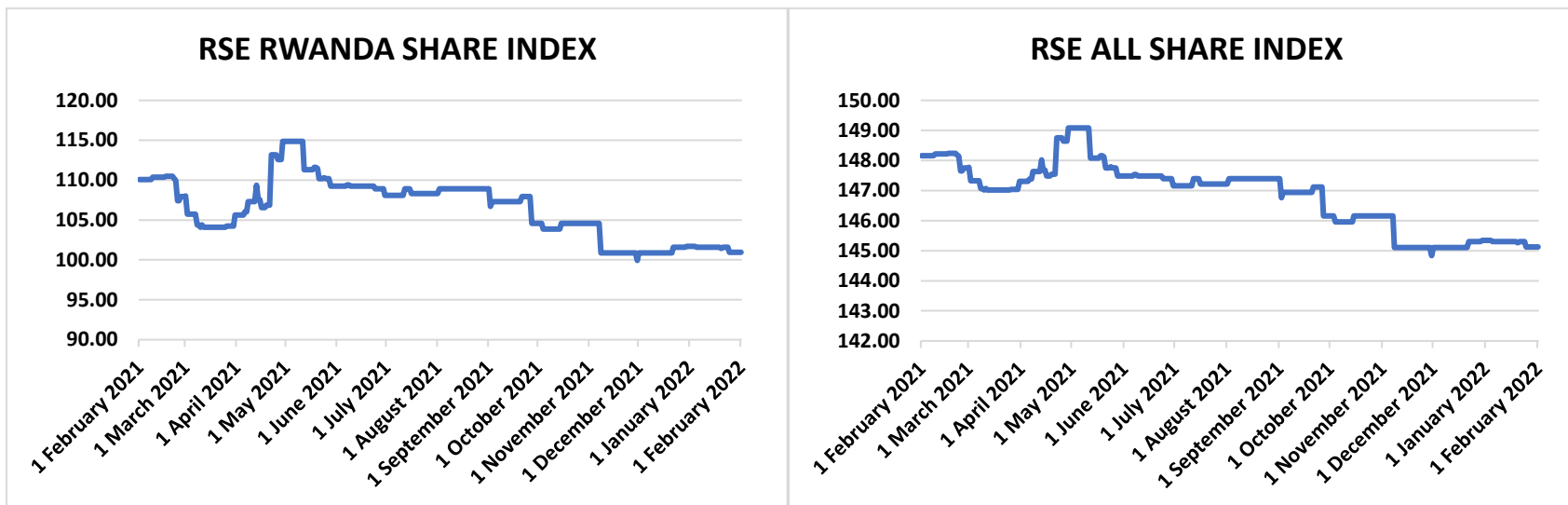
