



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 21<sup>ST</sup> NOVEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 21,536,000 worth of bonds traded in 2 deals on the fixed income market and Frw 1,254,900 from 10,800 shares traded in 6 deals on the equities market.
- RSI and ALSI went up by 0.12 and 0.03 points to close at 109.43 and 147.53 respectively.
- MTNR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 350,000 from 2,000 shares traded in 1 deal.
- BOK counter closed at Frw 272 (Frw 271 previous). The trading session recorded a total turnover of Frw 489,600 from 1,800 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 262,300 from 6,100 shares traded in 2 deals.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 153,000 from 900 shares traded in 1 deal.

- Equities counters closed as follows: CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 99,500 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,221,800 shares between Frw 175 - 180 and no bids. On BLR counter, there was an outstanding bid of 1,300 shares at Frw 170 and no offers. On IMR counter, there were outstanding offers of 301,600 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there was an outstanding offer of Frw 500,000 worth of bonds at Frw 106 and an outstanding bid of 1,000,000 worth of bonds at Frw 103.5.

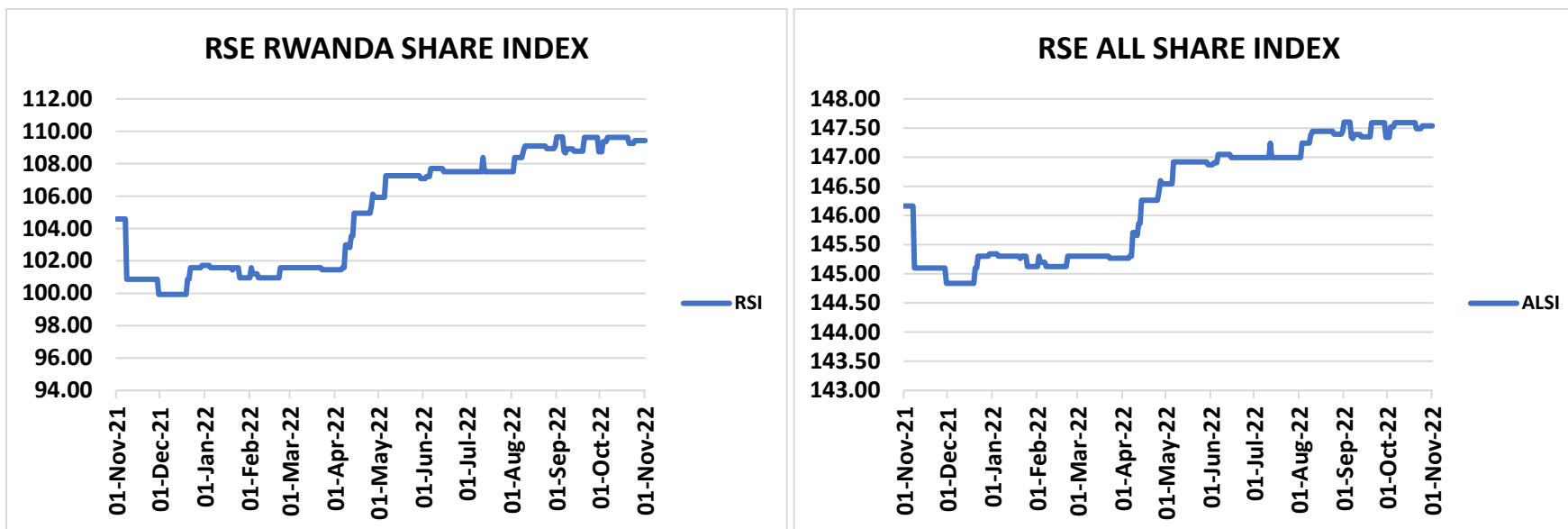
