



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 22<sup>ND</sup> AUGUST 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 21,020,000 worth of bonds traded in 2 deals on the fixed income market and Frw 43,000 from 1,000 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 109.10 and 147.44 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 43,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 165; BOK: Frw 272; CMR: Frw 120; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 367,000 shares between Frw 272 - 290 and no bids. On MTNR counter, there were outstanding offers of 1,030,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 109,600 shares between Frw 165 – 179 and outstanding bids of 3,800 shares at Frw 160. On IMR counter, there were outstanding offers of 283,300 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 112,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

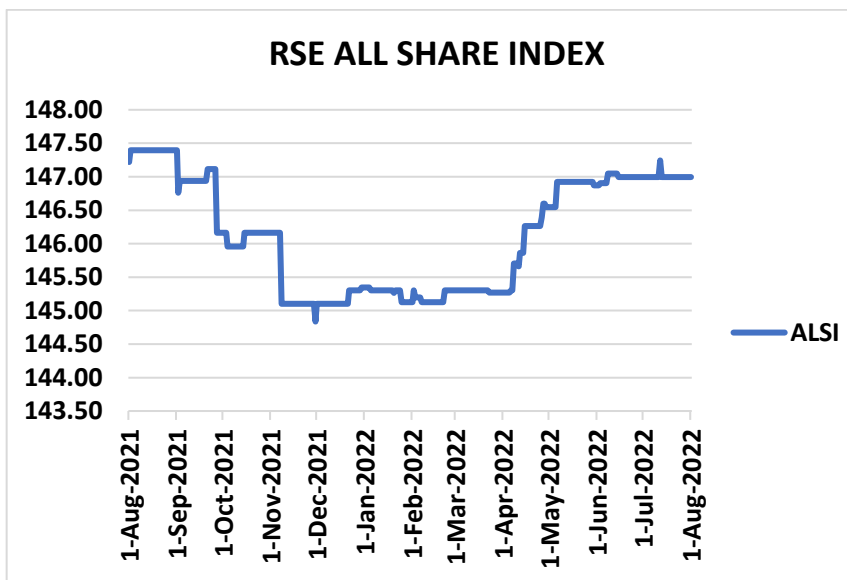
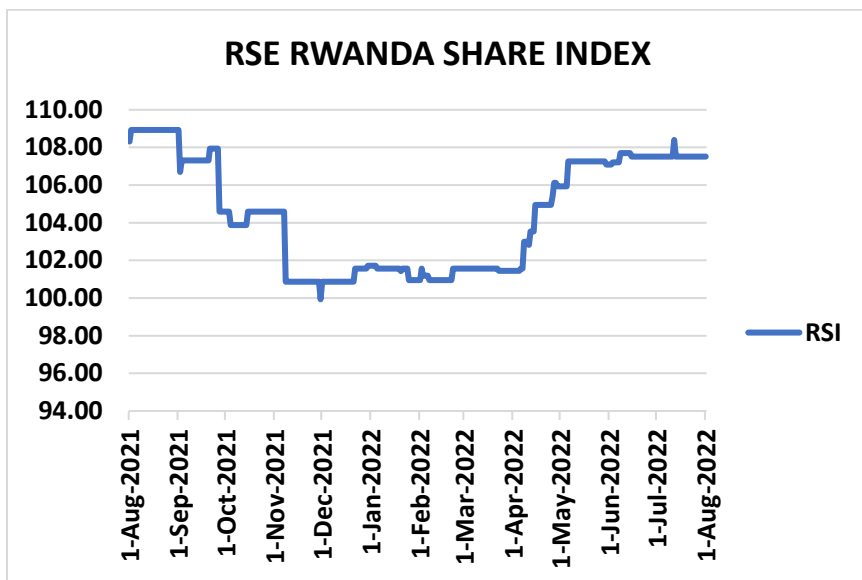
