



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 26TH FEBRUARY 2024

1. Market overview

- Today's trading session recorded a turnover of Frw 9,304,000 worth of bonds traded in 3 deals on the fixed-income market and Frw 182,000 from 1,100 shares traded in 2 deals on the equities market.
- RSI and ALSI remained constant to close at 115.69 and 144.47 respectively.
- BOK counter closed at Frw 300 (Frw 300 previous). The trading session recorded a total turnover of Frw 30,00 from 100 shares traded in 1 deal.
- CMR counter closed at Frw 152 (Frw 152 previous). The trading session recorded a total turnover of Frw 152,000 from 1,000 shares traded in 1 deal.

- Equities counters closed as follows: MTNR: Frw 170; BOK: IMR:43; BLR: Frw 174; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 945,200 shares between Frw 170 - 176 and no bids. On IMR counter, there were outstanding offers of 301,100 shares between Frw 43 - 45 and no bids. On BLR counter, there were outstanding offers of 336,400 shares between Frw 174 – 175 and no bids. On BOK counter, there were outstanding bids of 10,000 shares at Frw 275 and no offers.

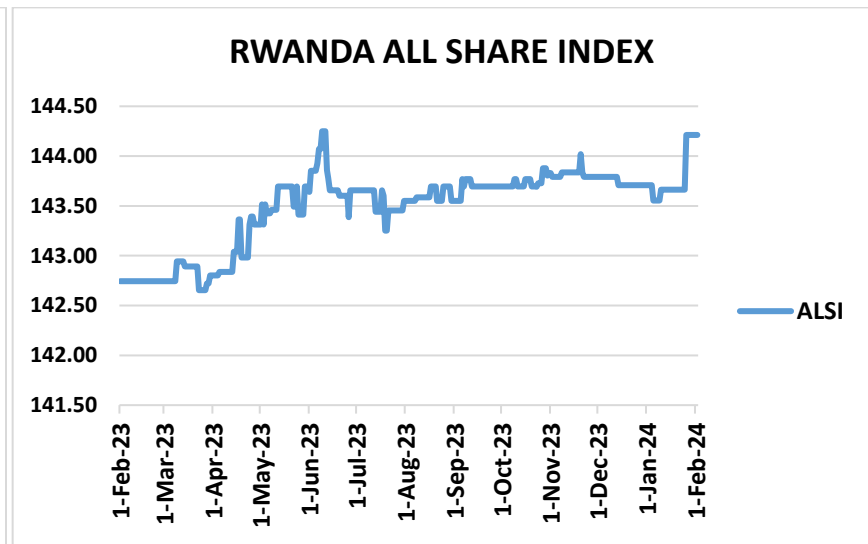
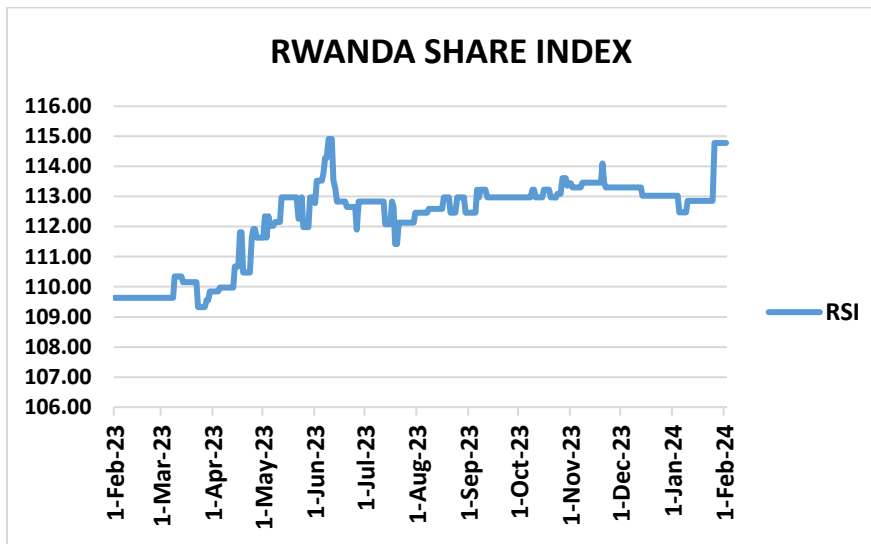
