



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 27TH FEBRUARY 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 21,842,200 worth of bonds traded in 2 deals on the fixed-income market and Frw 571,500 from 5,200 shares traded in 3 deals on the equities market.
- RSI and ALSI remained constant to close at 109.63 and 142.74 respectively.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 459,000 from 2,700 shares traded in 2 deals.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 112,500 from 2,500 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 271; MTNR: Frw 175; IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 40,500 shares between Frw 271-272 and no bids. On MTNR counter, there were outstanding offers of 1,236,100 shares between Frw 175-180 and no bids. On BLR counter, there were outstanding bids of 80,100 shares at Frw 160 and no offers. On IMR counter, there were outstanding offers of 233,900 shares at Frw 45 and an outstanding bid of 2,500 shares at Frw 40. On CMR counter, there were outstanding bids of 6,000 shares between Frw 120-122 and no offers.

On the bonds market, there were no offers and no bids.

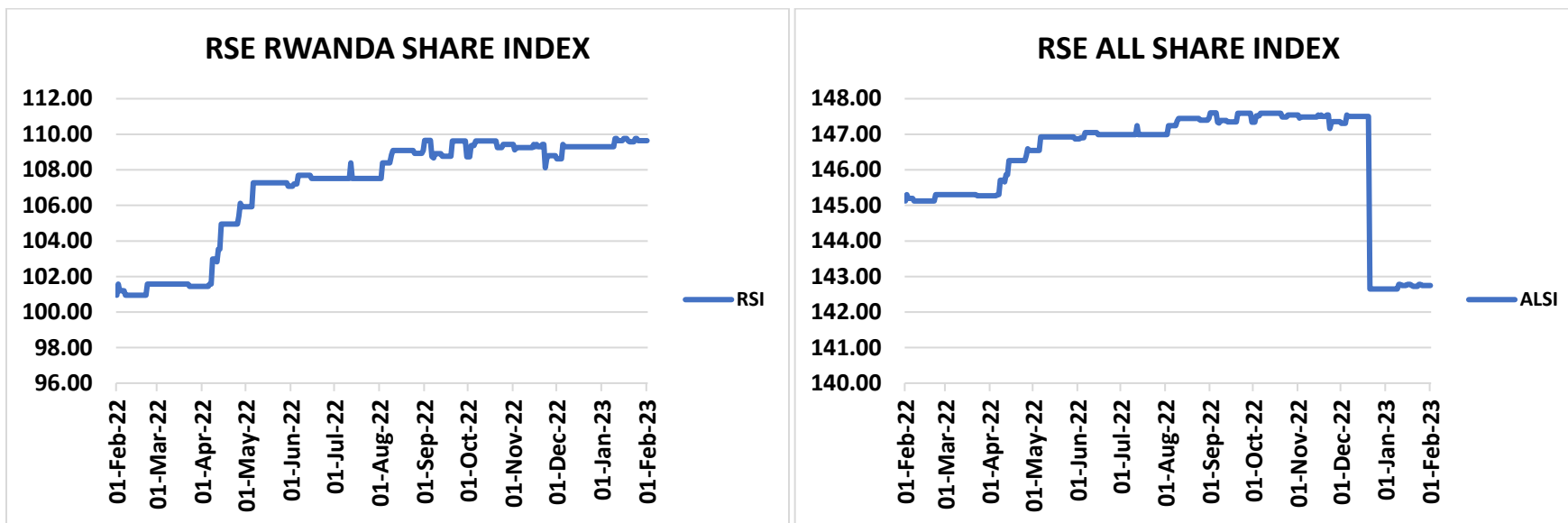
