



## RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 29<sup>TH</sup> AUGUST 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 41,923,700 worth of bonds traded in 5 deals on the fixed income market and Frw 336,000 from 8,000 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 108.93 and 147.39 respectively.
- IMR counter closed at Frw 42 (Frw 42 previous). The trading session recorded a total turnover of Frw 336,000 from 8,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 165; BOK: Frw 272; MTNR: Frw 177; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 375,100 shares between Frw 272 - 290 and an outstanding bid of 22,000 shares between Frw 245 - 247. On MTNR counter, there were outstanding offers of 910,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 64,800 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 76,300 shares between Frw 42 - 43 and no bids. On CMR counter, there were outstanding offers of 108,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

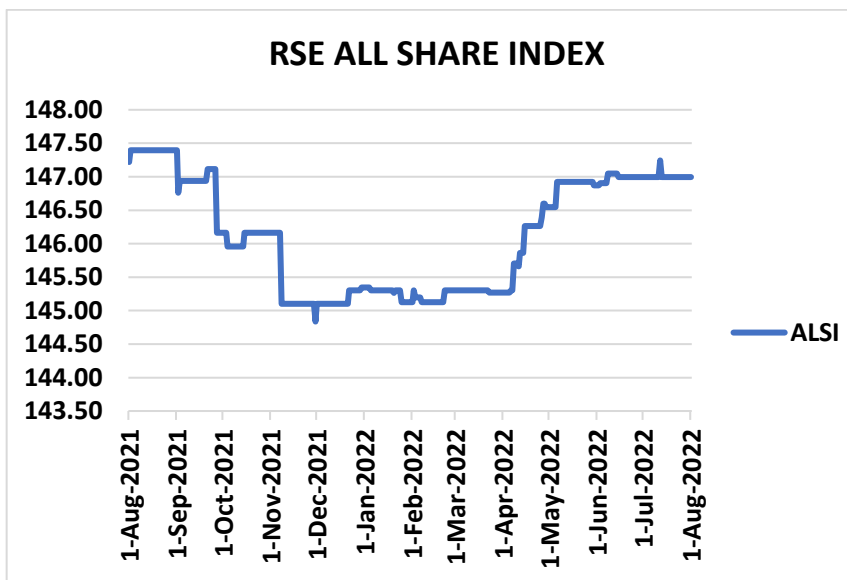
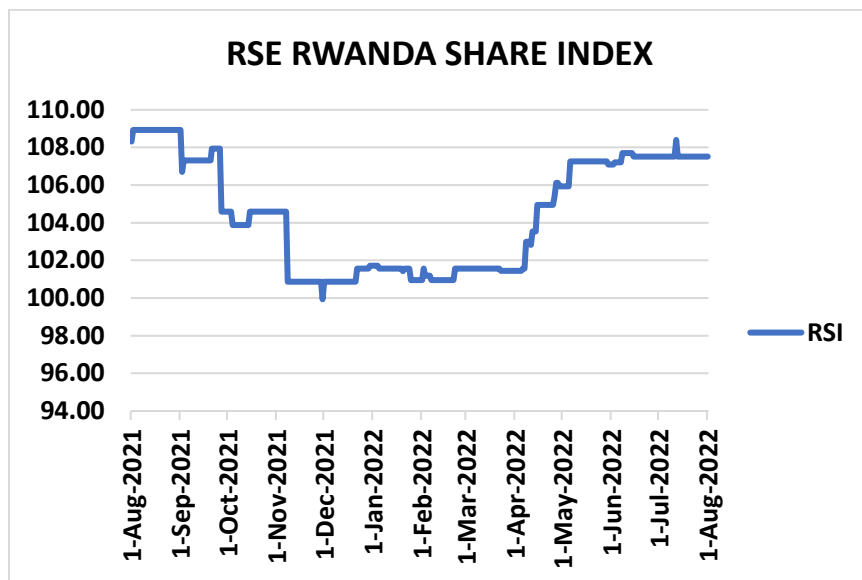
