



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 31ST JANUARY 2022

1. Market overview

- The trading session recorded a total turnover of Frw 137,500 from 1,100 BLR shares traded in 2 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 100.94 and 145.12 respectively.
- BLR counter closed at Frw 125 (Frw 125 previous). The trading session recorded a total turnover of Frw 137,500 from 1,100 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 245; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 41,200 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 600,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 96,000 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 373,900 shares at Frw 45 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market; there was an outstanding offer of Frw 10,000,000 worth of bonds at Frw 106 and no bids.

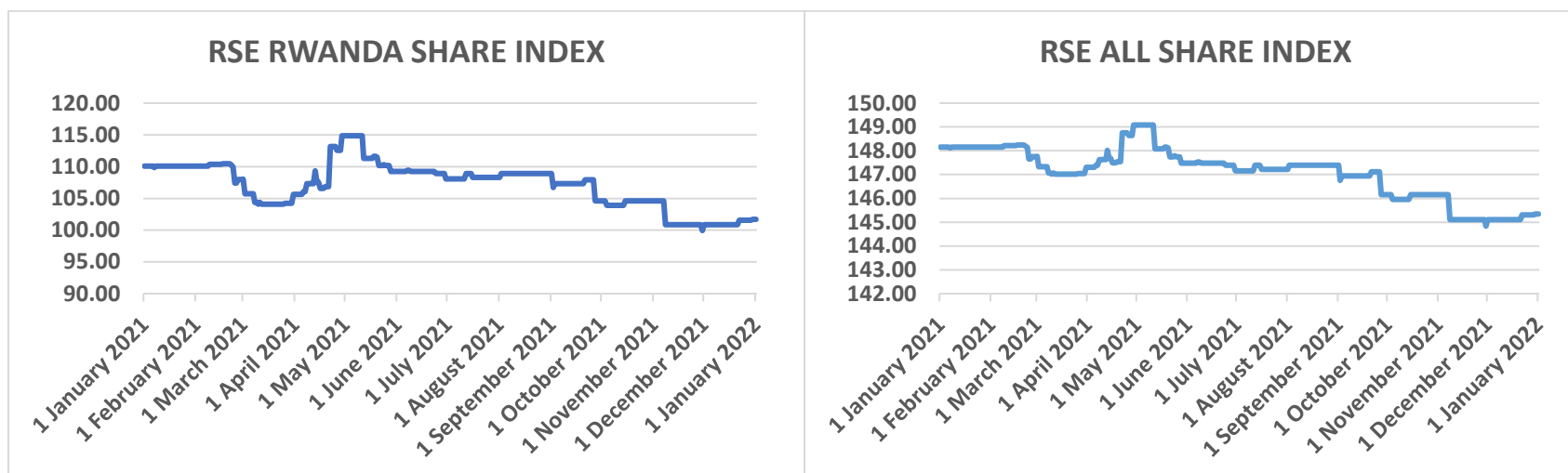
