



RWANDA STOCK EXCHANGE MARKET REPORT FOR MONDAY 7TH AUGUST 2023

1. Market overview

- Today's trading session recorded a total turnover of Frw 86,389,900 from 305,900 shares traded in 6 deals on the equities market and was quite on the fixed-income market.
- BLR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 1,619,500 from 9,500 shares traded in 4 deals.
- BOK counter closed at Frw 286 (Frw 286 previous). The trading session recorded a total turnover of Frw 84,770,400 from 296,400 shares traded in 2 deals.
- RSI and ALSI remain constant to close at 112.46 and 143.55 respectively.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 286; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 170; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 479,300 shares between Frw 170-176 and no bids. On IMR counter, there were outstanding offers of 221,600 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 11,100 shares at Frw 175 and outstanding bids of 50,000 shares at Frw 160. On BOK counter, there was no outstanding offers and outstanding bid of Frw 100 at Frw 285. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 132 and no bids.

On the bonds market, there were outstanding offers of Frw 20,000,000 at Frw 105.7 and no bids.

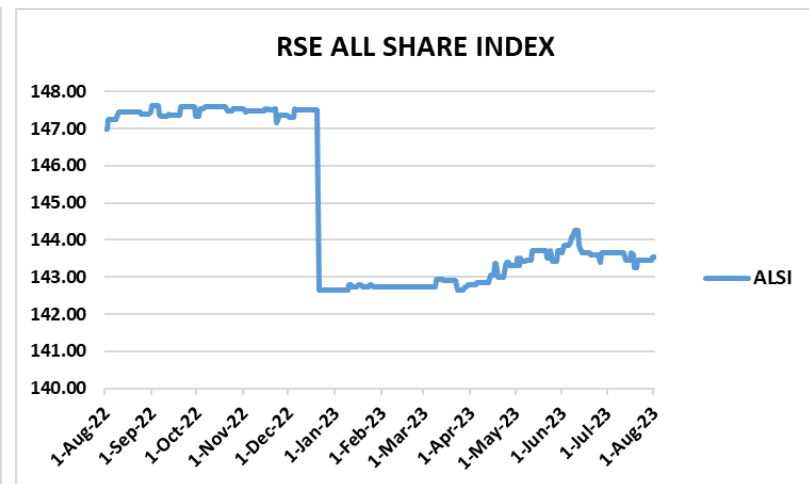
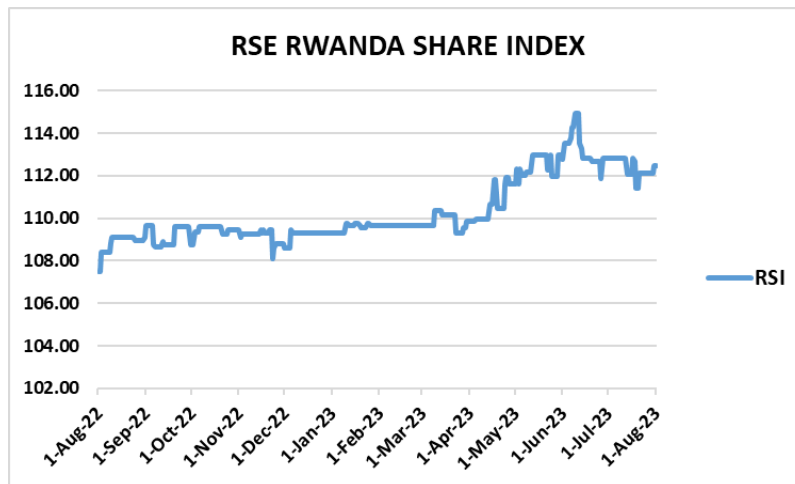
