



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 01ST SEPTEMBER 2022

1. Market overview

- Today's trading session was dominated by the equities market which recorded a total of Frw 4,514,131,800 from 26,260,000 shares traded in 15 deals while the fixed income market recorded 322,418,040 worth of bonds traded in 7 deals.
- RSI and ALSI went up by 0.55 and 0.15 points to close at 109.65 and 147.60 respectively.
- MTNR counter closed at Frw 180 (Frw 177 previous). The trading session recorded a total turnover of Frw 4,514,070,300 from 26,259,600 shares traded in 13 deals.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 49,500 from 300 shares traded in 1 deal.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 12,000 from 100 shares traded in 1 deal.

- Equities counters closed as follows: BOK: Frw 272; IMR: Frw 43; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 360,100 shares between Frw 272 - 290 and an outstanding bid of 22,000 shares between Frw 245 - 247. On BLR counter, there were outstanding offers of 65,800 shares between Frw 160 - 165 and no bids. On IMR counter, there were outstanding offers of 35,600 shares between Frw 42 - 43 and no bids. On CMR counter, there were outstanding offers of 104,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

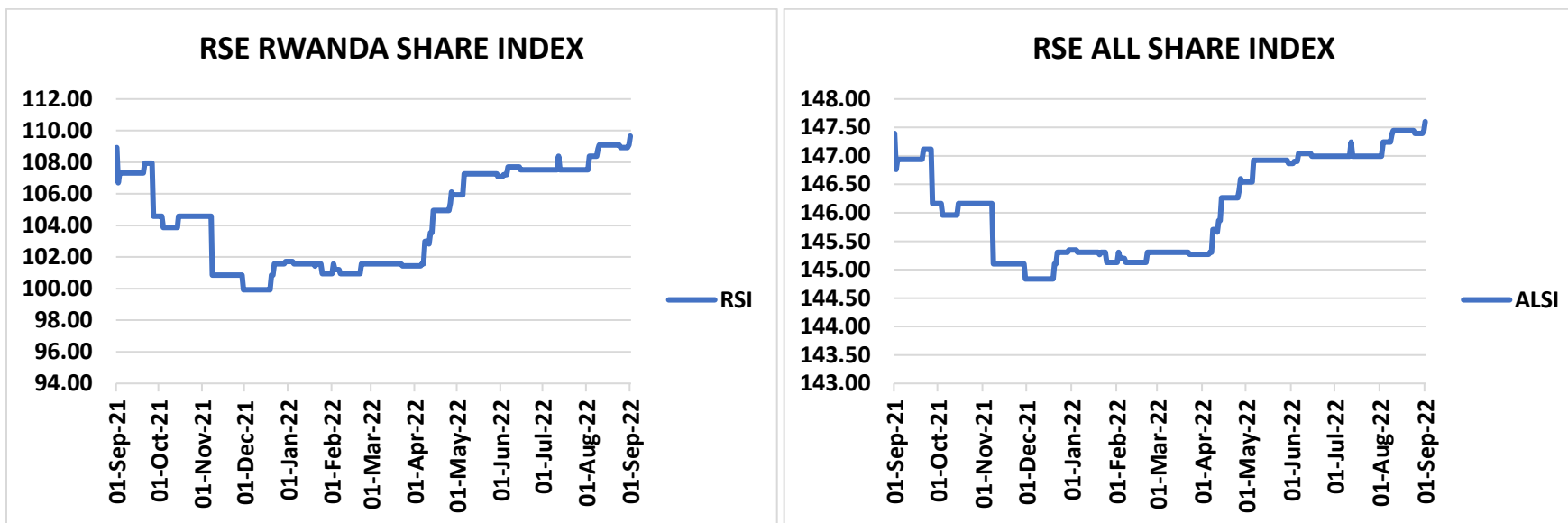
