



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 02ND DECEMBER 2021

1. Market overview

- The trading session recorded a turnover of Frw 710,908,500 worth of bonds traded in 1 deal on the fixed income market and Frw 975,000 from 3,900 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 975,000 from 3,900 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 120; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 20,400 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 520,600 shares between Frw 180-195 and no bids. On BLR counter, there were outstanding offers of 81,300 shares at Frw 120 and outstanding bids of 110,000 shares between Frw 115-116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 374,600 shares between Frw 45-47 and no bids.

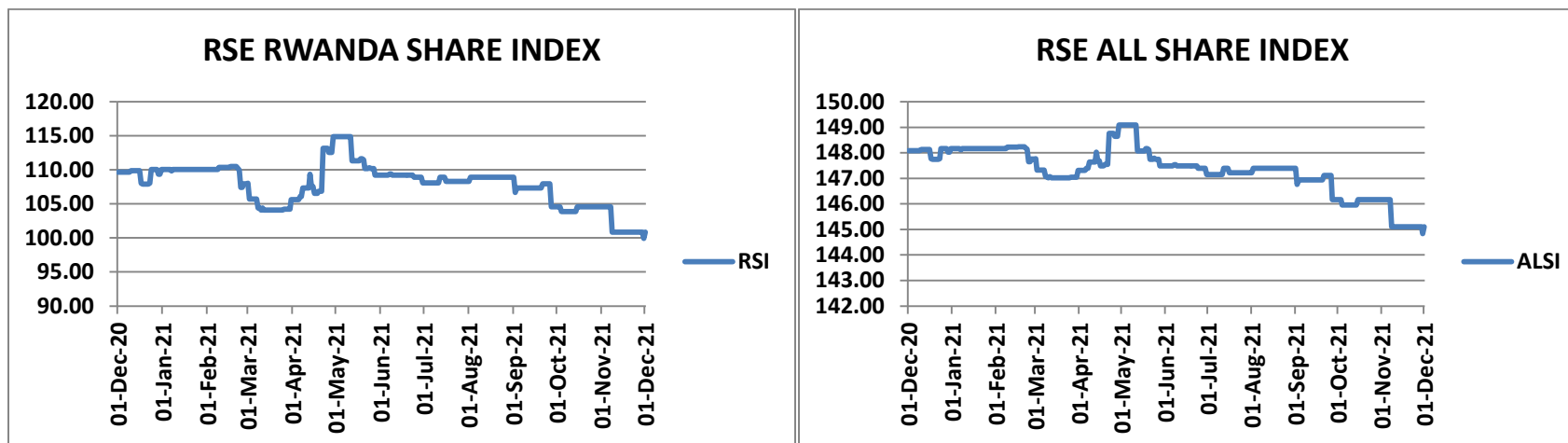
