

RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 03RD FEBRUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 7,167,900 from 33,100 shares traded in 3 deals on the equities market and Frw 2,659,500 worth of bonds traded in 1 deal on the fixed income market.
- RSI and ALSI went down by 0.37 and 0.10 points to close at 101.19 and 145.19 respectively.
- BOK counter closed at Frw 247 (Frw 250 previous). The trading session recorded a total turnover of Frw 6,718,400 from 27,200 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 162,000 from 3,600 shares traded in 1 deal.
- BLR counter closed at Frw 125 (Frw 125 previous). The trading session recorded a total turnover of Frw 287,500 from 2,300 shares traded in 1 deal.




