- EQTY counter closed at Frw 440 (Frw 445 previous). The trading session recorded a total turnover of Frw 440,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 65, BOK: Frw 265, BLR: Frw 139; IMR: Frw 90; KCB: Frw 370; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

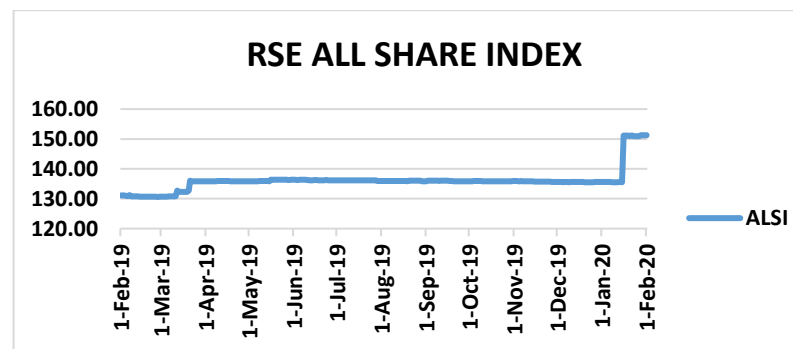
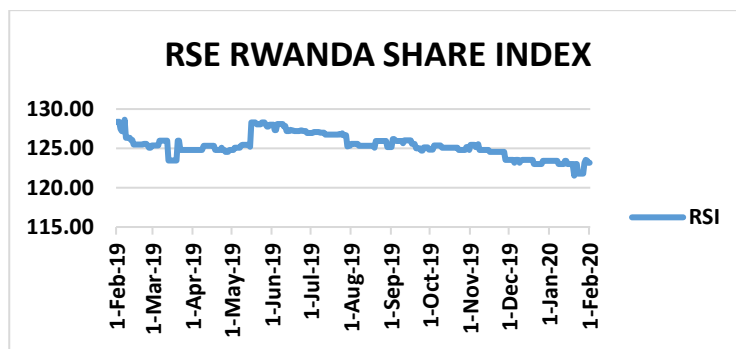
