



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 06TH OCTOBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 7,119,000 worth of bonds traded in 1 deal on the fixed income market and Frw 244,800 from 900 BOK shares traded in 2 deals on the equities market.
- RSI and ALSI went up by 0.25 and 0.07 points to close at 109.61 and 147.59 respectively.
- BOK counter closed at Frw 272 (Frw 270 previous). The trading session recorded a total turnover of Frw 244,800 from 900 shares traded in 2 deals.
- Equities counters closed as follows: BLR: Frw 170; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 54,100 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,233,400 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 9,700 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 224,100 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 105,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

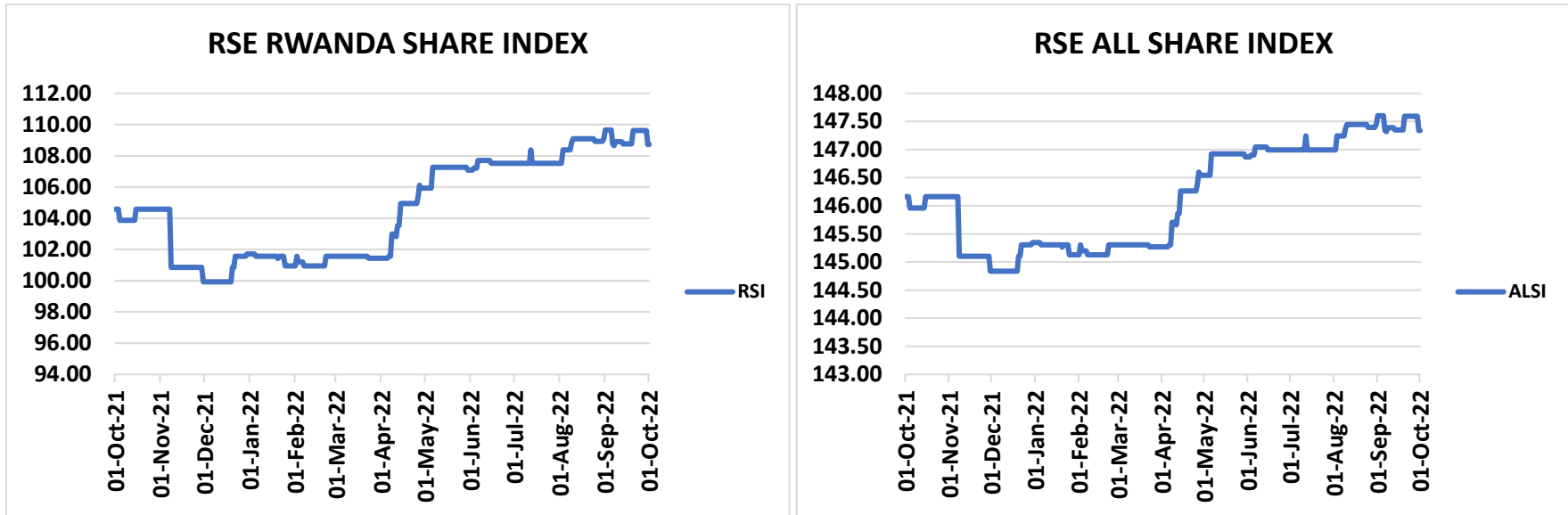
