



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 07<sup>TH</sup> JANUARY, 2021

### 1. Market overview

- Today's trading session recorded on the equities market a total of Frw 129,924,500 from 1,197,600 shares traded in 6 deals while the fixed income market recorded Frw 5,300,000 worth of bond traded in 1 deal.
- RSI and ALSI went down 0.22 and 0.04 points to close at 109.82 and 148.11 respectively.
- BLR counter closed at Frw 120 (Frw 121 previous). The trading session recorded a total turnover of Frw 128,162,000 from 1,165,100 shares traded in 2 deals.
- CTL counter closed at Frw 75 (Frw 75 previous). The trading session recorded a total turnover of Frw 750,000 from 10,000 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 1,012,500 from 22,500 shares traded in 3 deals.
- Equities counters closed as follows: BOK: Frw 233; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

### 2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 219,700 shares between Frw 227-240 and no bids. On BLR counter, there were outstanding offers of 153,900 shares between Frw 120-136 and no bids. On CTL counter, there were outstanding bids of 103,700 shares between Frw 67-75 and no offers. On IMR counter, there were outstanding offers of 117,500 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

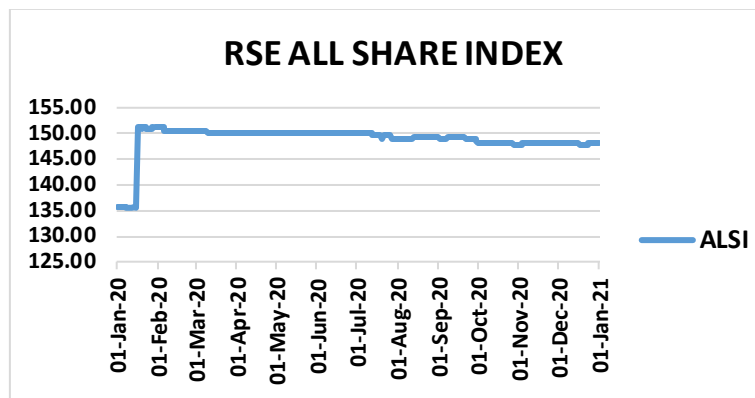
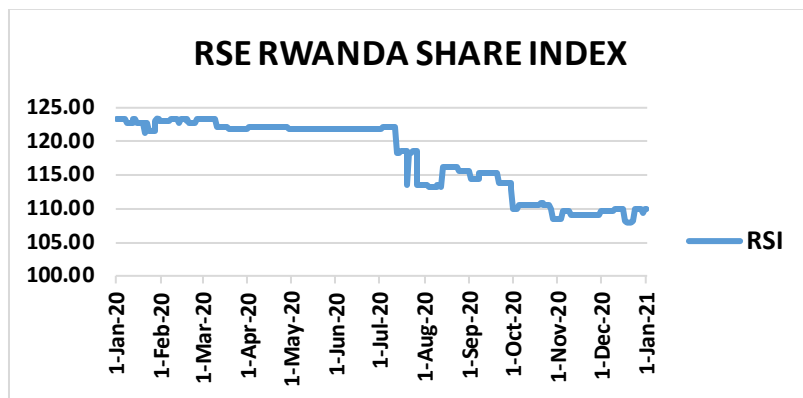
