



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 07TH JULY 2022

1. Market overview

- Today's trading session recorded a turnover of Frw 42,181,800 worth of bonds traded in 6 deals on the fixed income market and Frw 4,750,700 from 39,400 shares traded in 7 deals on the equities market.
- RSI and ALSI remained constant to close at 107.51 and 146.99 respectively.
- MTNR counter closed at Frw 177 (Frw 177 previous). The trading session recorded a total turnover of Frw 2,362,900 from 13,500 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 627,800 from 14,600 shares traded in 2 deals.
- BLR counter closed at Frw 160 (Frw 160 previous). The trading session recorded a total turnover of Frw 1,616,000 from 10,100 shares traded in 2 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 144,000 from 1,200 shares traded in 1 deal.

- Equities counters closed as follows: BOK: Frw 265; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding bid of 700 shares at Frw 260 and an outstanding offer of 395,000 shares at Frw 275. On MTNR counter, there were outstanding offers of 1,206,600 shares between Frw 177-180 and no bids. On BLR counter, there were outstanding offers of 124,800 shares between Frw 160–165 and no bids. On IMR counter, there were outstanding offers of 291,300 shares between Frw 43-45 and no bids. On CMR counter, there were outstanding offers of 112,000 shares at Frw 120 and no bids.

On the bonds market, there was an outstanding offer of Frw 3,500,000 at Frw 105.5 and no bids.

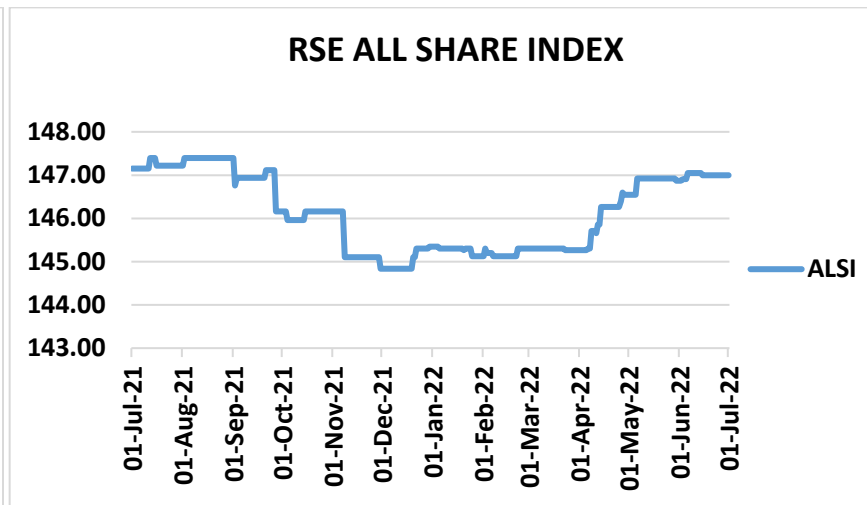
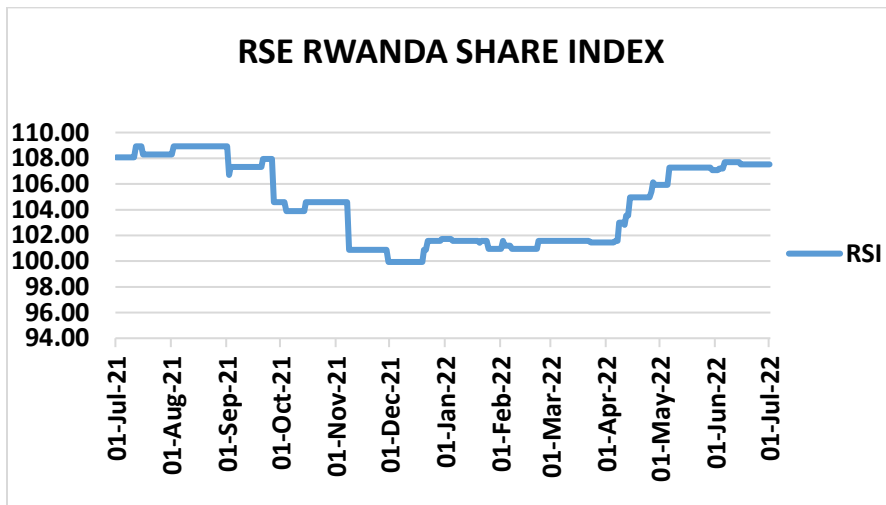
