



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 10<sup>TH</sup> MARCH 2022

### 1. Market overview

- Today's trading session recorded Frw 26,430,000 worth of bonds traded in 3 deals on the fixed income market and Frw 8,878,000 from 79,200 shares traded in 4 deals on the equities market.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 36,000 from 200 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 157,500 from 3,500 shares traded in 1 deal.
- BLR counter closed at Frw 125 (Frw 125 previous). The trading session recorded a total turnover of Frw 8,684,500 from 75,500 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 250; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 14,500 shares between Frw 245-250 and no bids. On MTNR counter, there were outstanding offers of 750,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 69,400 shares at Frw 125 and an outstanding bid of 24,700 shares at Frw 115. On IMR counter, there were outstanding offers of 524,200 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market; there were no outstanding offers and no bids.

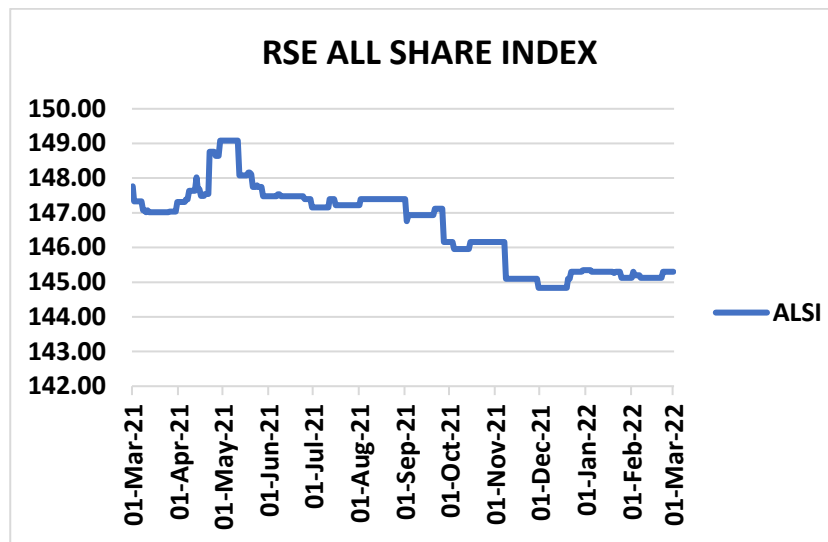
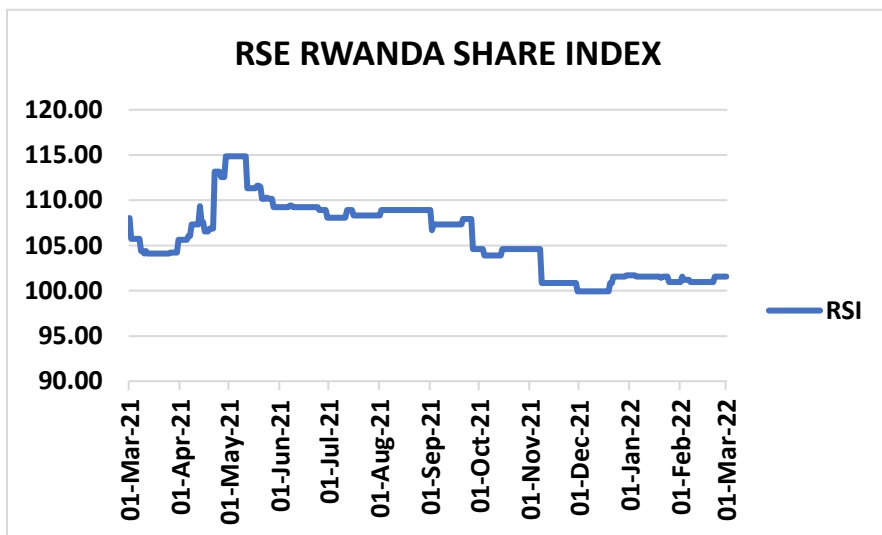
