- CTL counter closed at Frw 65 (Frw 69 previous). The trading session recorded a total turnover of Frw 975,000 from 15,000 shares traded in 1 deal.

2. Closing bell

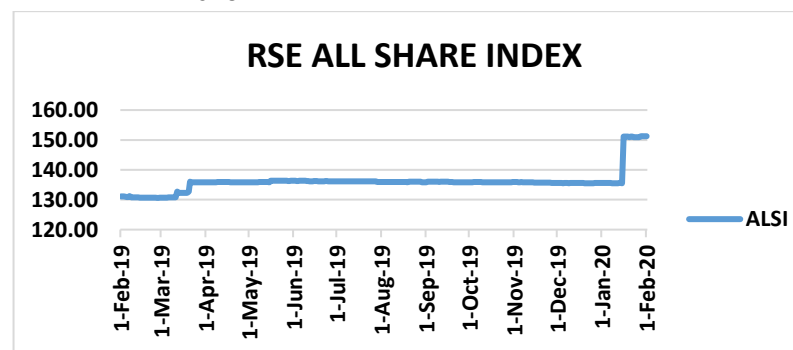
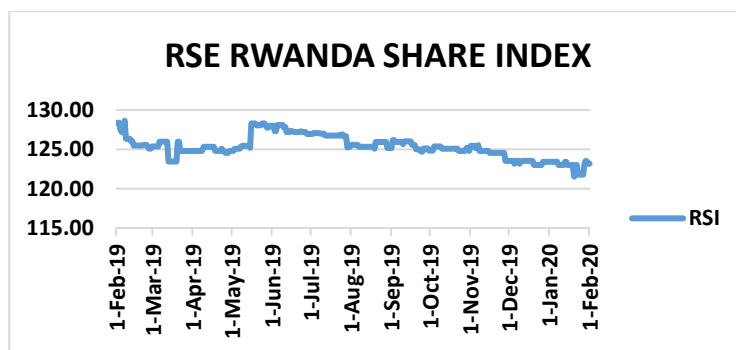
