



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 14<sup>TH</sup> OCTOBER 2021

### 1. Market overview

- The trading session recorded a turnover of Frw 5,595,000 worth of bonds traded in 2 deals on the fixed income market and Frw 225,000 from 5,000 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 103.88 and 145.95 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 225,000 from 5,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 115; BOK: Frw 250; CMR: Frw 120; MTNR: Frw 200; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 15,400 shares at Frw 260 and no bids. On MTNR counter, there were outstanding offers of 1,050,000 shares between Frw 200-225 and no bids. On BLR counter, there were outstanding offers of 112,100 shares between Frw 120-125 and outstanding bids of 110,000 shares between Frw 115-116. On CMR counter, there were outstanding offers of 110,200 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 375,100 shares between Frw 45-47 and no bids.

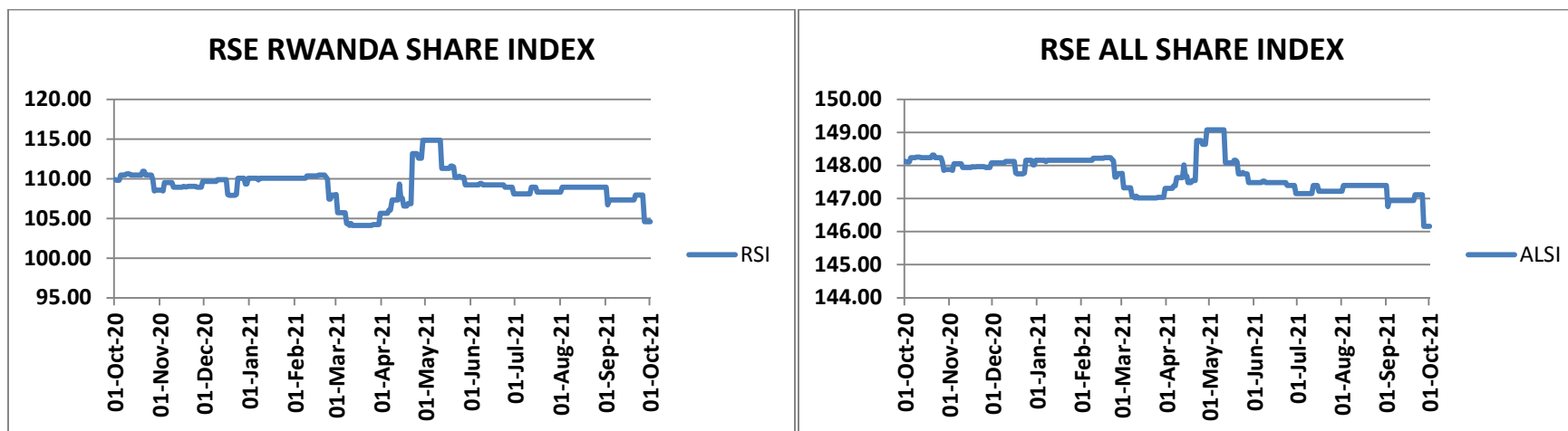
