



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 17TH FEBRUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 2,292,400 worth of bonds traded in 2 deals on the fixed income market and Frw 459,000 from 10,200 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 100.94 and 145.12 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 459,000 from 10,200 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 125; BOK: Frw 245; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 30,000 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 700,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 90,600 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 572,200 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

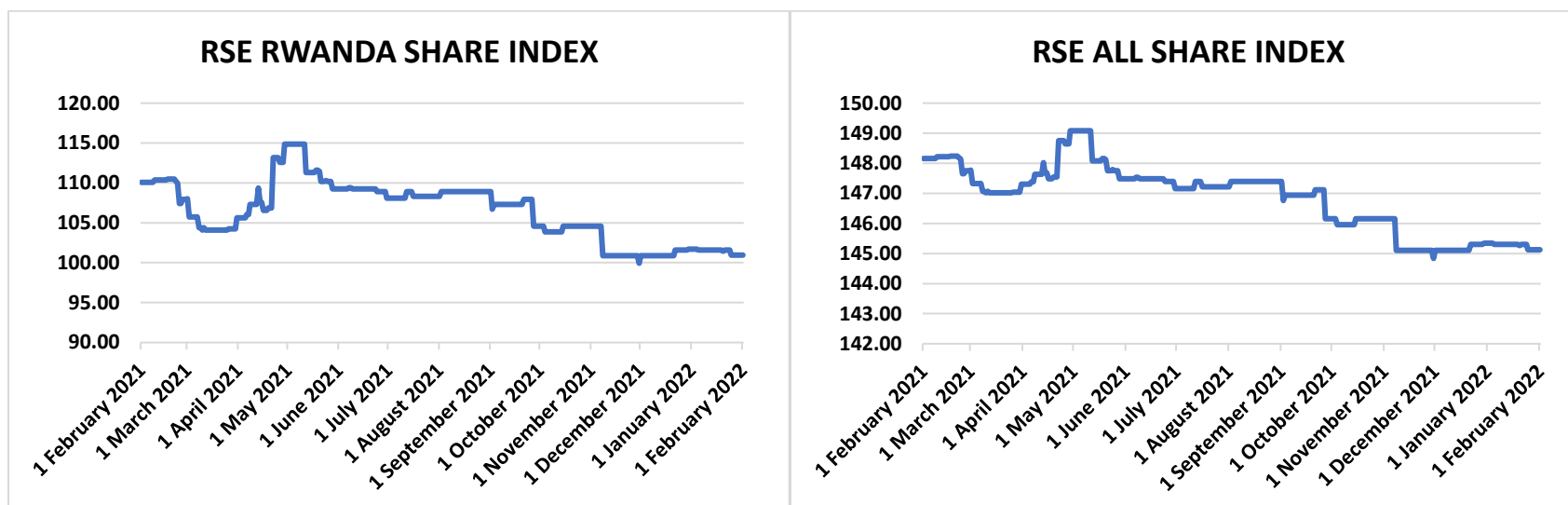
