



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 17TH NOVEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 28,320,000 worth of bonds traded in 2 deals on the fixed income market and Frw 496,400 from 2,500 shares traded in 2 deals on the equities market.
- RSI and ALSI went up by 0.12 and 0.03 points to close at 109.43 and 147.53 respectively.
- BOK counter closed at Frw 272 (Frw 271 previous). The trading session recorded a total turnover of Frw 190,400 from 700 shares traded in 1 deal.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 306,000 from 1,800 shares traded in 1 deal.

- Equities counters closed as follows: IMR: Frw 43; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 100,600 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,225,600 shares between Frw 175 - 180 and no bids. On BLR counter, there was an outstanding bid of 1,200 shares at Frw 170 and no offers. On IMR counter, there were outstanding offers of 312,800 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there was an outstanding offer of Frw 500,000 worth of bonds at Frw 106 and no bids.

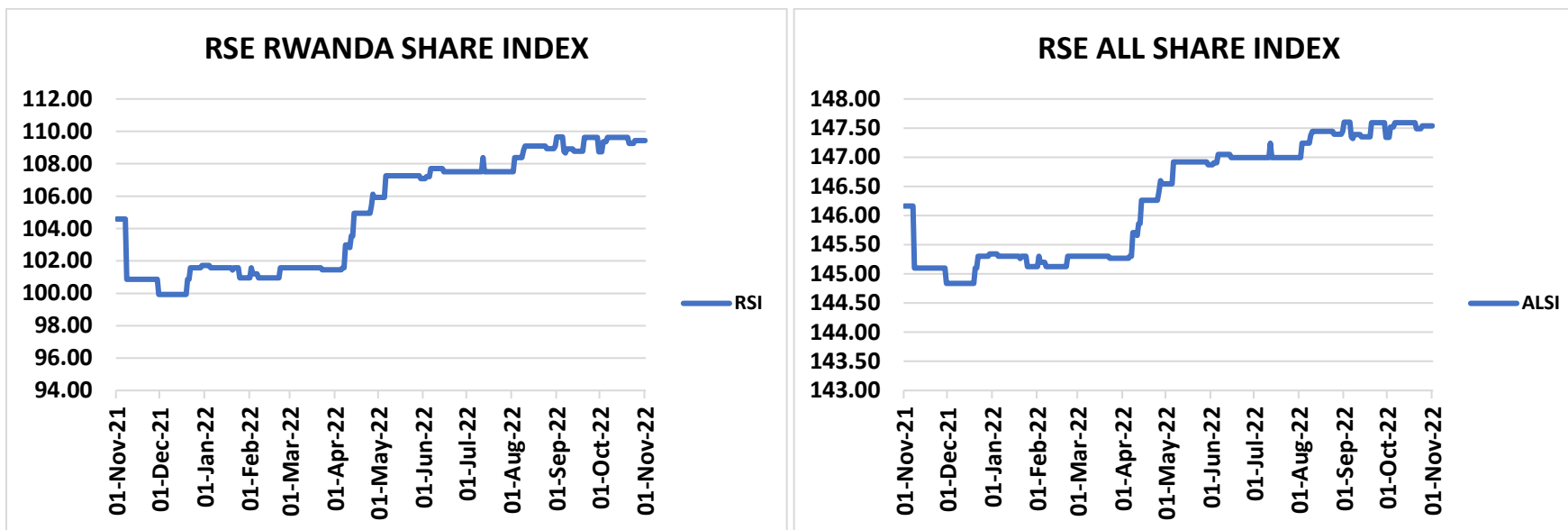
