



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 19<sup>TH</sup> JANUARY 2023

### 1. Market overview

- The trading session recorded a total turnover of Frw 41,033,500 from 242,100 shares traded in 5 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI went down by 0.12 and 0.03 points to close at 109.63 and 142.74 respectively.
- BOK counter closed at Frw 271 (Frw 272 previous). The trading session recorded a total turnover of Frw 379,400 from 1,400 shares traded in 2 deals.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 9,000 from 200 shares traded in 1 deal.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 40,645,100 from 240,500 shares traded in 2 deals.

- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 33,700 shares between Frw 271 - 272 and no bids. On MTNR counter, there were outstanding offers of 1,212,100 shares between Frw 175 - 180 and no bids. On BLR counter, there were outstanding offers of 12,200 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 253,900 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 1,100 shares between Frw 120 - 122 and no offers.

On the bonds market, there were no offers and no bids.

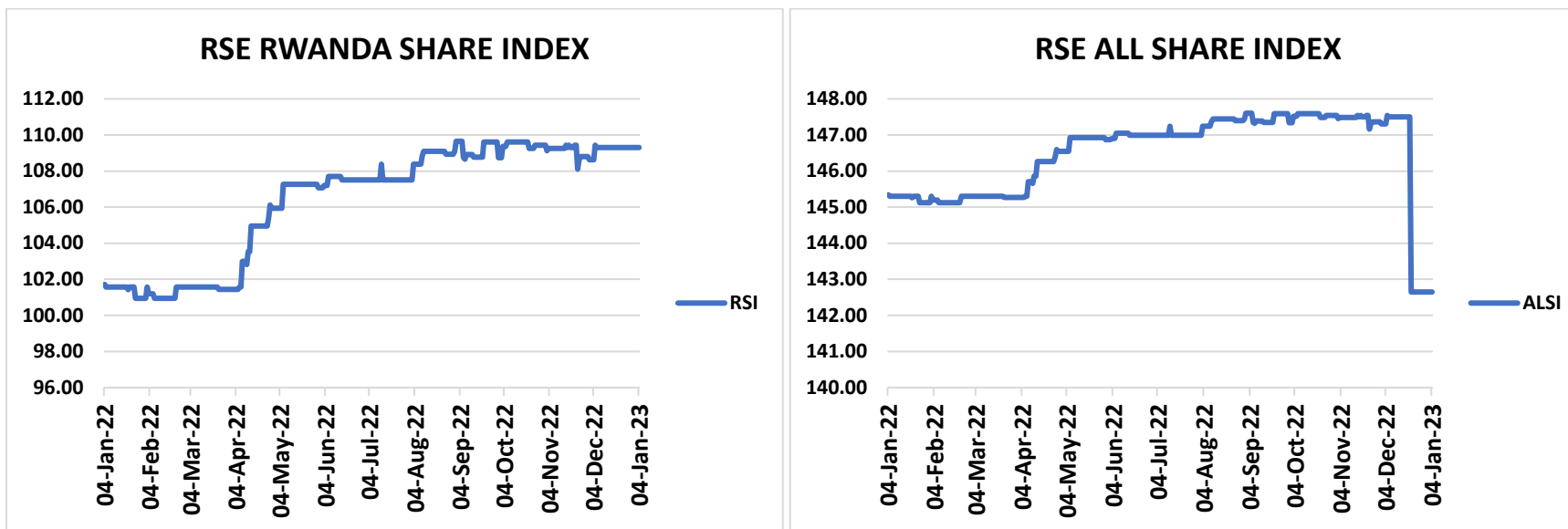
