1. Market overview

- RSI and ALSI went down 0.37 and 0.06 points to close at 123.02 and 150.35 respectively.
- Today's trading session recorded a total of Frw 50,025,000 worth of bond traded in 1deal and Frw 292,500 from 4,500 shares traded in 1 deal.
- CTL counter closed at Frw 65 (Frw 70 previous). The trading session recorded a total turnover of Frw 292,500 from 4,500 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 265; BLR: Frw 139; IMR: Frw 89; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

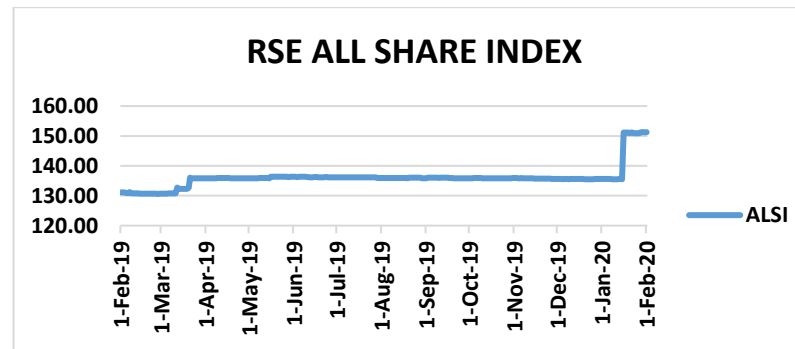
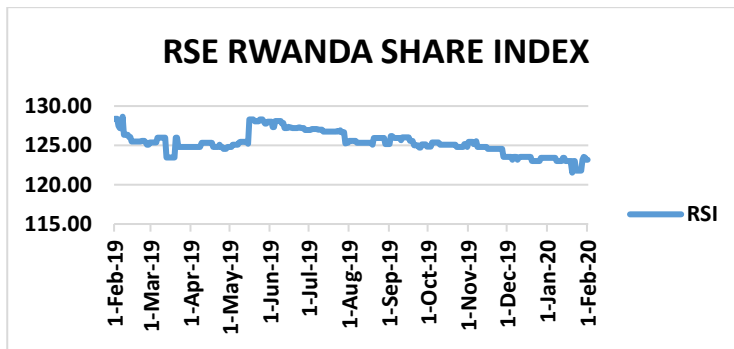
