



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 22<sup>ND</sup> SEPTEMBER 2022

### 1. Market overview

- Today's trading session remained quiet as no transactions were recorded on both the equities and fixed income markets.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw: 272; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 375,700 shares between Frw 272 - 290 and an outstanding bid of 1,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,305,200 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding bid of 3,000 shares at Frw 160 and no offers. On IMR counter, there were outstanding offers of 167,900 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 105,800 shares at Frw 120 and no bids.

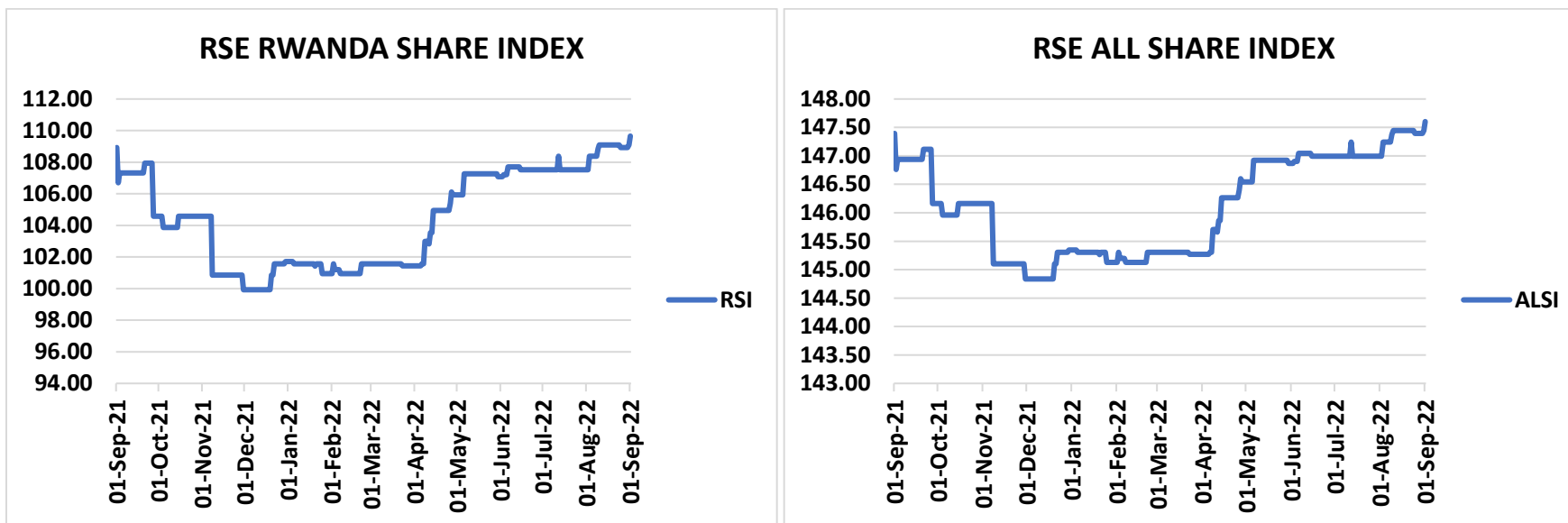
