



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 23RD MARCH 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 1,184,429,400 worth of bonds traded in 1 deal on the fixed-income market and Frw 28,990,000 from 159,500 shares traded in 3 deals on the equities market.
- RSI and ALSI went down by 0.83 and 0.24 points to close at 109.32 and 142.65 respectively.
- BOK counter closed at Frw 270 (Frw 271 previous). The trading session recorded a total turnover of Frw 6,615,000 from 24,500 shares traded in 1 deal.
- BLR counter closed at Frw 170 (Frw 175 previous). The trading session recorded a total turnover of Frw 22,375,000 from 135,000 shares traded in 2 deals.
- Equities counters closed as follows: IMR: Frw 45; CMR: Frw 120; MTNR: Frw 174; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 18,600 shares between Frw 271 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,290,100 shares between Frw 174 - 180 and no bids. On BLR counter, there was an outstanding offer of 49,000 shares at Frw 175 and an outstanding bid of 400 shares at Frw 160. On IMR counter, there were outstanding offers of 245,400 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 25,100 shares between Frw 122 - 125 and no offers.

On the bonds market, there were no offers and no bids.

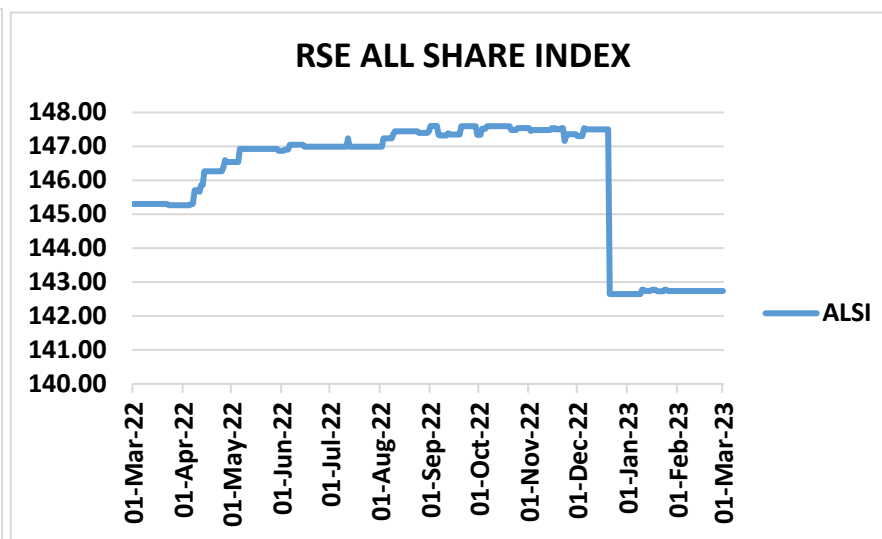
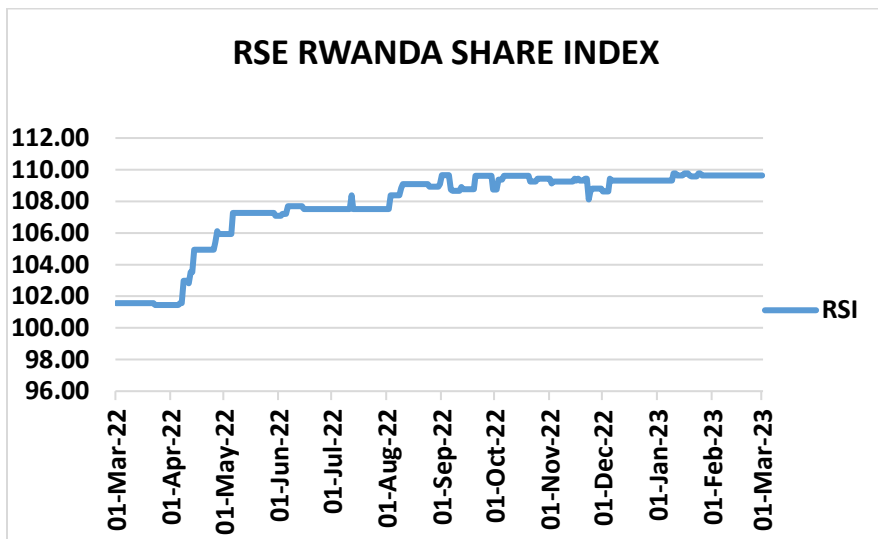
