



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 24<sup>TH</sup> DECEMBER 2020

### 1. Market overview

- Today's trading session recorded on the equities market Frw 3,073,800 from 23,900 shares traded in 7 deals while the fixed income market was quiet.
- RSI and ALSI went up 2.02 and 0.38 points to close at 110.05 and 148.15 respectively.
- BOK counter closed at Frw 233 (Frw 225 previous). The trading session recorded a total turnover of Frw 1,654,300 from 7,100 shares traded in 1 deal.
- CTL counter closed at Frw 75 (Frw 72 previous). The trading session recorded a total turnover of Frw 917,500 from 12,500 shares traded in 3 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 372,000 from 3,100 shares traded in 1 deal.
- BLR counter closed at Frw 121 (Frw 120 previous). The trading session recorded a total turnover of Frw 121,000 from 1,000 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 9,000 from 200 shares traded in 1 deal.

- Equities counters closed as follows: EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

### 2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 187,400 shares between Frw 227-230 and no bids. On BLR counter, there were outstanding offers of 193,200 shares between Frw 120-136 and no bids. On CTL counter, there were outstanding offers of 7,500 shares between Frw 72-75 and outstanding bids of 36,100 shares between Frw 67-70. On IMR counter, there were outstanding offers of 74,300 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

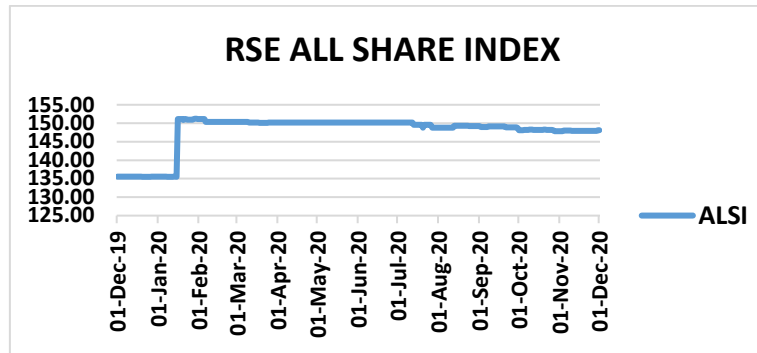
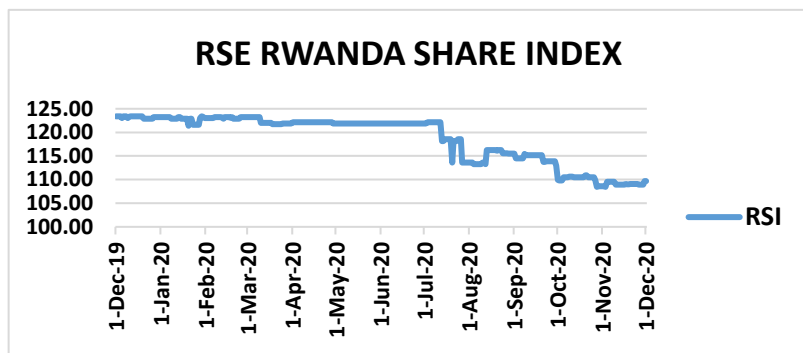
