



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 24TH NOVEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 129,687,500 worth of bonds traded in 7 deals on the fixed income market and Frw 14,796,000 from 54,800 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI went down up by 0.50 and 0.14 points to close at 108.61 and 147.30 respectively.
- BOK counter closed at Frw 270 (Frw 266 previous). The trading session recorded a total turnover of Frw 14,796,000 from 54,800 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 166; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 84,800 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,224,500 shares between Frw 175 - 180 and no bids. On IMR counter, there were outstanding offers of 257,600 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there were outstanding offers of Frw 8,000,000 worth of bonds between Frw 101.5 - 106 and an outstanding bid of Frw 30,200,000 worth of bonds at Frw 100.5.

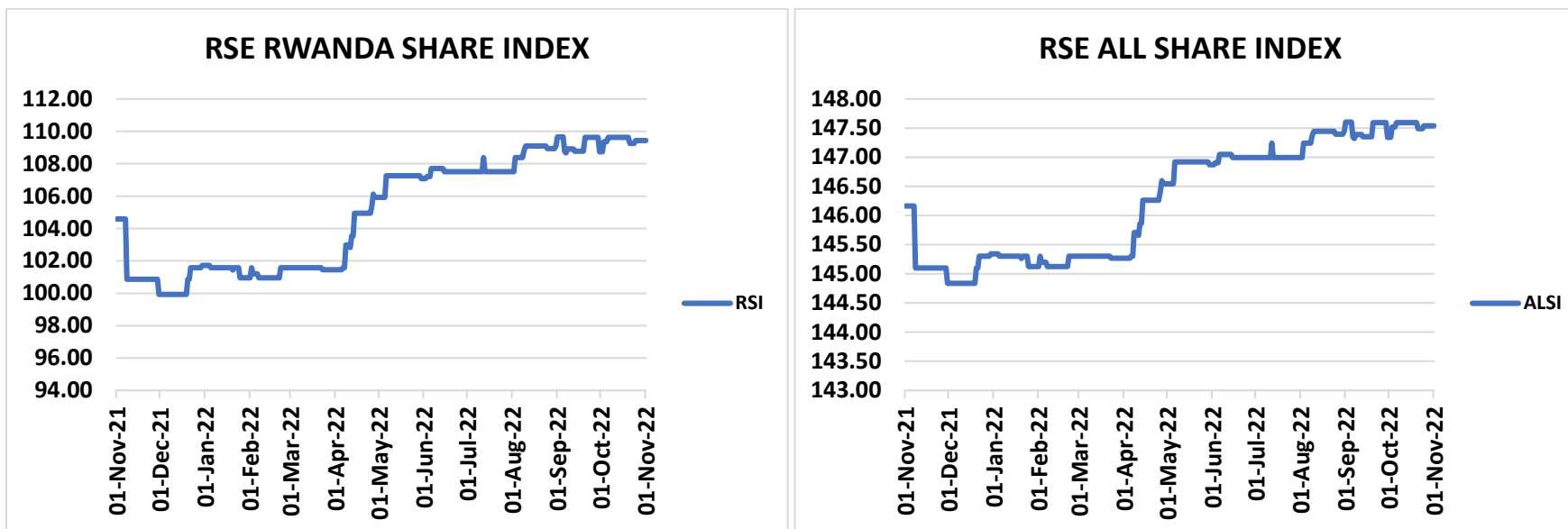
