



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 25TH AUGUST 2022

1. Market overview

- The trading session recorded a turnover of Frw 175,154,200 from 1,103,500 shares traded in 6 deals on the equities market and Frw 3,030,000 worth of bonds traded in 1 deal on the fixed income market.
- RSI and ALSI went down by 0.16 and 0.04 points to close at 108.93 and 147.39 respectively.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 174,677,000 from 1,091,700 shares traded in 4 deals.
- IMR counter closed at Frw 42 (Frw 43 previous). The trading session recorded a total turnover of Frw 477,200 from 11,800 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 272; CMR: Frw 120; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 371,900 shares between Frw 272 - 290 and an outstanding bid of 22,000 shares between Frw 245 - 247. On MTNR counter, there were outstanding offers of 910,300 shares between Frw 177 - 180 and no bids. On BLR counter, there was an outstanding offer of 2,800 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 81,700 shares between Frw 42 - 43 and no bids. On CMR counter, there were outstanding offers of 108,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

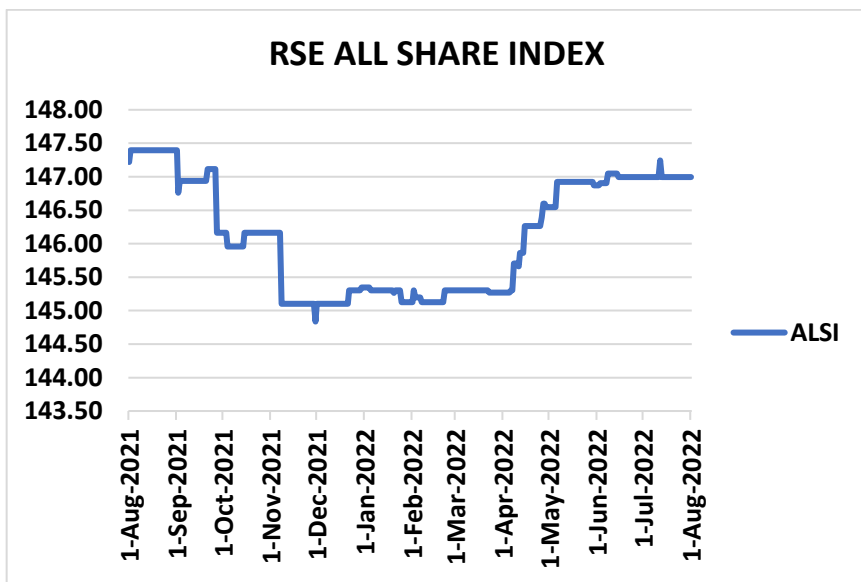
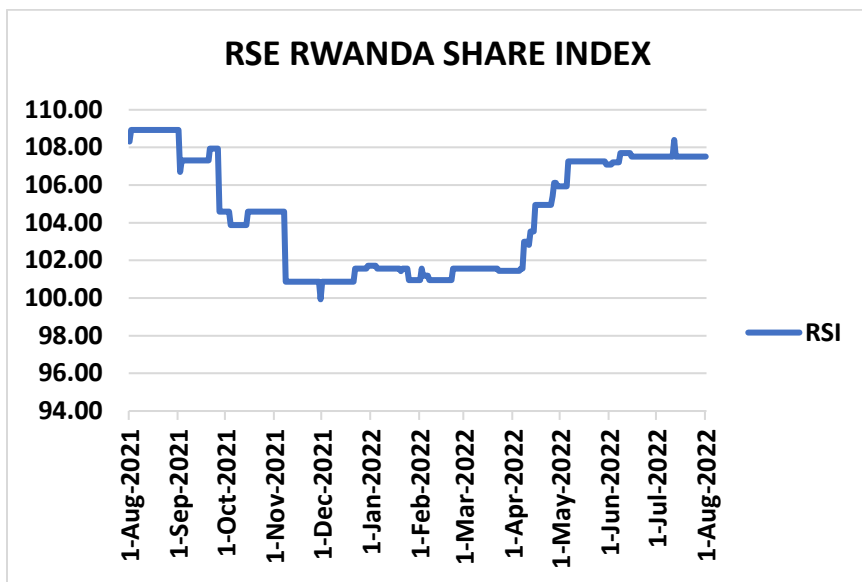
