



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 27<sup>TH</sup> OCTOBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 682,598,910 worth of bonds traded in 5 deals on the fixed income market and Frw 786,900 from 18,300 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 109.43 and 147.53 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 786,900 from 18,300 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 272; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 108,800 shares between Frw 272 - 280 and an outstanding bid of 20,700 shares at Frw 262. On MTNR counter, there were outstanding offers of 1,320,300 shares between Frw 175 - 180 and no bids. On BLR counter, there was an outstanding offer of 1,300 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 238,600 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 104,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

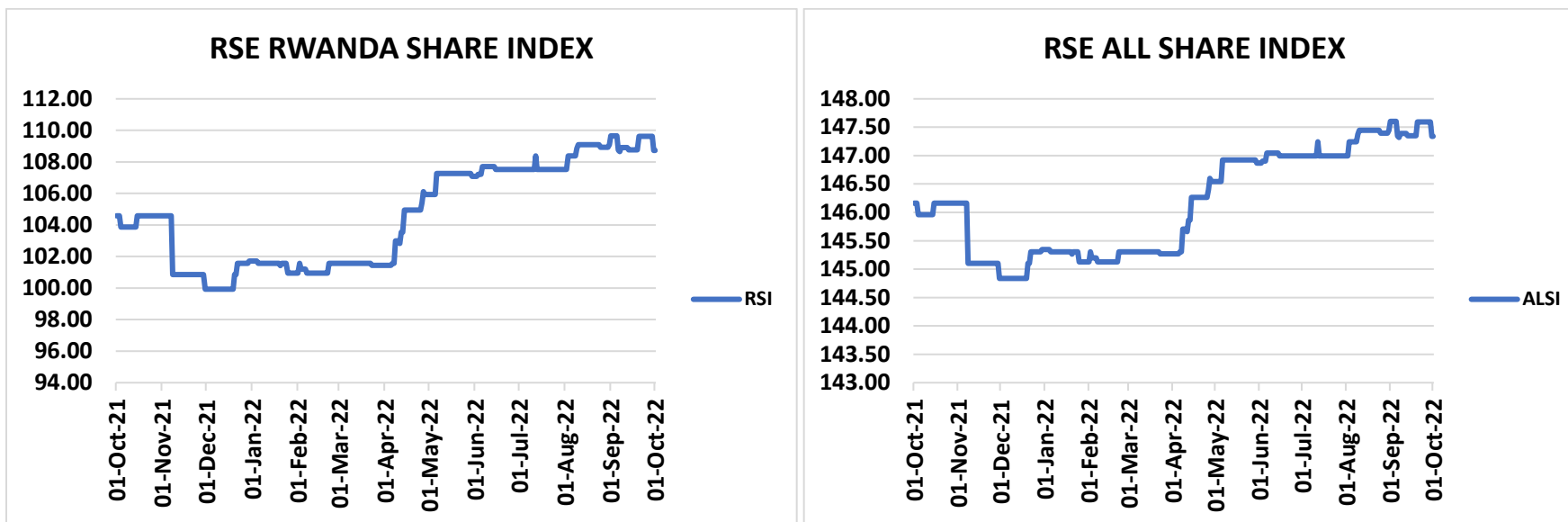
